Recommendation for architectural services to provide

professional programming and conceptual design services for a

new police / fire and EMS facility.

The evaluation committee met on Monday, May 20, 1996 to consider the ten (10) proposals submitted for the above referenced services. The committee members individually rated the proposals and those scored were tabulated and totaled to determine the best overall proposal. The results of the evaluation process and the recommendation of the committee are set forth on the attached sheet. The committee unanimously concurred on the selection of GDM Inc. as the most qualified firm to provide the services.

RECOMMENDATION

It is recommended that the council affirm the selection of GDM Inc. and authorize the Administration to negotiate a professional services agreement for the proposed services, in an amount not to exceed \$40,000.
