STATUS: Preliminary engineering by 2/15. Option being considered to use "unattached" bike trail design similar to Lucille bikepath and avoid expense of curb and gutter design. This also facilitates using the current road alignment which is not lined in the center of the ROW. The bikepath will be on the north side of Spruce on MSB land. As of 1/19/98, we are still waiting to hear about MSB contribution on (dust control) paving expenses.

2. WEBER DRIVE Parks Highway to Nelson Drive

STATUS: Replat / Public Use Easement in progress. Discussions held with DOT/PF re: storm drain system coordination and Parks intersection realignment. Property owners (Wendys, Weber, & Johnson) meeting held with DPW 1/6 to coordinate project with adjacent owners. (curb and gutter + bikepath) 900 lf to connect Parks to Nelson.

3. NORTH COUNTRY ESTATES

Paving LID proposed

Denali North \$881,000

STATUS: Preliminary design completed. Public informational meeting scheduled for Wednesday 1/14. Formal survey of interest will be sent to property owners via registered mail. Public hearings will follow. Total cost of LID estimated \$881,000.

Preliminary estimated cost divided by 67 property owners (if all parcels are assumed to be equal) would result in approximately \$4,5000 assessment per property owner.

4. SUSITNA DRIVE

LID proposed \$266,000

\$450,000 est. to lake

STATUS: No new estimates at this time.

Estimates (2/25/93) based on 71 lots. Does not include the last 2000 lf. to Lake Lucille.

The LID was not worked into this process in '93. City's share on Susitna Ave was 66% and 30% on side streets. This would all change to normal LID 66% City share on all paving.

5. EASTERN EXTENSION OF CITY WATER

Estimates Pending

There is interest from commercial developers in extension of the water/sewer utilities in areas which will be affected by the coming Parks Highway up-grades. There may be interest in pushing ahead of major work by DOT/PF.

During our meeting on LID formation on December 30, 1997 you requested public works to investigate the feasibility of an LID project for the Susitna Avenue area on the south side of town.

As I understand it, the original LID formation consisted of Floyd subdivision, Blocks 1 thru 8 and Kennedy Addition, Blocks 2, 3 & 4. This proposal includes Kennedy Addition Blocks 1 thru 14 and Blocks 4 & 5 of Floyd Subdivision.

The roads department continues to hear from the local property owners in that area about the lack of maintenance and dust control. Because of the continuing dust and maintenance problems caused by residential and commercial traffic we propose the following for LID boundaries.

Option 1. Susitna Avenue from Lake Street to Denali Street in its entirety.

Option 2. As specified in option 1 but to include three cross streets, Boundary, Talkeetna and Denali Streets.

REASON:


Option 1 - Susitna Avenue west of KGB leads to activity at Carter Park and Lake Lucille boat launch. Although no traffic counts have been done in recent years. it is obvious from the maintenance stand point that traffic use has increased substantially. All utilities are in with the exception of a storm drainage pipeline that would need to be placed before construction. There are no recent soils tests of that area, but several excavations over the past few years indicate good soils.

Susitna Avenue East to Denali Street suggests minor problems from the soils standpoint as well as base utilities and storm drainage to be addressed.

Page 2 Memo Susitna Ave

The side streets added in option 2 could create some problems such as R-O -W, utilities and drainage. The soil material should be of the same quality as Susitna Avenue. Because of the R-Of -W, some excess materials in the form of overburden may need to be excavated.

I added these streets to the option because of property development as well as the fact that original LID shows good support for the project.

2. WEBER DRIVE Parks Highway to Nelson Drive

4. SUSITNA DRIVE

5. DANNA DRIVE

Approximately 1,500 linear feet of paving would connect Lucille Drive and Fishhook and improve traffic flow. It may be best to delay to coordinate design with DOT/PF and the Bogard / Fishhook intersection

6. CHURCH ROAD SOUTH

CIP

R & M Engineering

STATUS:

Engineering completed. Wetlands permit acquired.

7. LUCILLE AVENUE Danna Avenue to Spruce Avenue

STATUS: Needs storm sewer up-grades and re-cap with 1.5" of asphalt. <u>Estimated</u> cost: \$250-350,000. Capping at this point in the maintenance schedule will extend the life of the road 15-20 years, even with current heavy traffic load.

OTHER PAVING PROJECTS not currently on the priority list

(LIDs can be reprioritized to reflect property owner interest.)

1. SWANSON AVENUE

STATUS: Needs resurfacing, storm drain corrections, and subsurface improvements. This project requires engineering to problem solve and maximize return on investment. Costs unknown.

2. MYSTERY AVENUE Church Road east through Bumpus to Lucus

STATUS: No road currently connects the ballfields east to Lucus. R.O.W. acquisition and clearing are required as well as engineering and design on 4,000 '. Cost estimate: unknown, but in the \$700,000 range. Improvements on 1,300' developed road have estimated cost of \$145,000 range.

3. RECLUSE Paving LID proposed

STATUS: 14 of the 57 homeowners in the proposed LID responded to letters of interest sent by Jeff Williams. 13 of those returned were in favor of the LID formation. This area is part of the LID proposed for Melanie Avenue which did not go forward summer '97.

4. MELANIE Paving LID proposed Denali North

STATUS: There is still interest in dust control / paving. DOT/PF traffic counters were gathering data earlier in December. There may be a method of splitting the previous LID into Recluse and Melanie sections, perhaps with different accounting systems.

5. WINTER / HOLIDAY Paving LID proposed

STATUS: 8/97, 21 property owners (of 87) responded positively to an informal survey re: interest in forming a paving LID. City Council approved funding to obtain preliminary engineering and cost estimates. DPW staff was heavily committed with wrap-up of other projects and the project did not go forward in '97.

6. VAUNDA Paving LID proposed

STATUS: The property owners rejected the previous funding formula.

7. SENECA to PECK Paving LID proposed

STATUS: Initiated, but not active at this time
