SUMMARY: The bid opening for this project was held at 2 p.m., May 27, 1998. The three submitted bids were read aloud, as follows:

D&L Construction \$578,936 Wilder Construction 581,835 Jim Psenak Construction 593,964

I have reviewed the bids and found that one bid irregularity existed with the apparent low bidder, D&L Construction. D&L Construction failed to submit a statement of non-collusion with its bid package. D&L Construction submitted this statement at 2:47 p.m., May 27.

Attached is a memorandum I prepared explaining the irregularity. Also attached is a legal opinion prepared by the City's attorney, Kenneth Jacobus, P.C. Mr. Jacobus states that the irregularity "should be waived by the City under the circumstances of this bidding."

With the resolution of this irregularity, the D&L Construction bid complies with the bid conditions and instructions. I have determined that D&L Construction submitted the lowest responsive bid.

D&L Construction failed to submit its Non-Collusion Affidavit in its bid package opened at 2:00 p.m. on May 27, 1998, and submitted the affidavit at 2:47 p.m. the same day. The failure to submit this affidavit is a type of irregularity or informality which may be waived by the City of Wasilla in its decision to award the contract.

In federal procurement, where most of the decisions arise, certain general principles have developed. Under federal law, a minor informality or irregularity <u>must</u> be waived, regardless of the contracting officer's preference. What is a minor informality or irregularity, however, is now always easy to decide. Generally, deviations which affect price, quantity, quality or delivery cannot be waived. Other types of deviations which might prejudice any other bidder in having his or her bid fairly considered and evaluated should also not be waived. Under federal law, it has been determined that failure to return all required documents is a waivable irregularity.

In summary, failure of D&L Construction to submit the Non-Collusion Affidavit with its bid package is an irregularity or informality which should be waived by the City of Wasilla under the circumstances of this bidding.

Since it is not necessary to provide an opinion on the failure of Psenak Construction to provide a sufficient bid bond, I will not do so. This issue presents a complicated question because the premium on a bond could very well affect the bid price, and this irregularity may very well be non-waivable.

In the future, when an irregularity or informality occurs in a City bid, I would appreciate an opportunity to review the situation. The issues presented by these irregularities and informalities are sometimes very complicated, and are almost always fact specific to the particular procurement. A legal review should be conducted in each circumstance in order to best insure

that the City of Wasilla is protected against future challenges to the bidding and acceptance process.

Re: Spruce Avenue Phase 1A Bid Opening, Irregularities

<u>Issue:</u> Two irregularities arose during the Spruce Avenue bid opening, including one by the company (D&L Construction) submitting the lowest bid. Wilder Construction submitted the second lowest bid. Wilder is questioning whether D&L should be disqualified for failing to submit all of the required documents before the bid opening.

The issue for the City administration to decide is whether it will waive the bidding irregularity and recommend that the Council award the contract to D&L Construction.

<u>Background:</u> The Spruce Avenue paving contract bid opening was held at 2 p.m. on May 27, 1998 in the City Council hearing room. Three firms submitted bid packages (Wilder Construction, Jim Psenak Construction, and D&L Construction). Each of the firms had a representative at the bid opening. The lowest bid was submitted by D&L Construction.

However, two of the three bid packages did not completely comply with the instructions to bidders. (See the attached page 4 of the Contract Documents prepared by Alaska Rim Engineering and lated May 11, 1998). These irregularities are:

L Construction did not include the Non-Collusion Affidavit. During the bid opening, City staff and I verified that this document was not included in the submitted bid package and was so stated during the bid opening. D&L submitted this statement at 2:47 p.m. that same day.

Page 2 of the City's Contract Documents is the formal "Invitation to Bid" (attached). On this page is the statement.

"The City of Wasilla reserves the right to reject any and all Bids, and to waive any informalities and irregularities in Bidding or awarding of the Contract."

Jim Psenak Construction provided only a 5% bid bond. The Contract Documents states that the bidder is to comply with "provisions of Section 10.02, Bidding Requirements and Conditions." That document states that a bid bond shall be 10% of the bid. (I recommend that in future proposals that the bid documents specifically state that a 10% bond is required.)

Chapter 3.4, Action on Bids, City Specifications

<u>Summary:</u> The Administration may desire to have an attorney review the Instructions to Bidders to determine if the failure for D&L to timely submit the Non-Collusion Affidavit warrants disqualifying that firm from receiving the contract.
