ADDENDUM NO. 5

to

AGREEMENT TO FURNISH ANIMAL CONTROL ENFORCEMENT AND SHELTER SERVICES between the THE MATANUSKA-SUSITNA BOROUGH and the CITY OF WASILLA

THIS AMENDMENT NO. 4 hereby amends the Agreement to Furnish Animal Control Enforcement and Shelter Services between the Matanuska-Susitna Borough and the City of Wasilla dated November 18, 1993, as follows:

Section 1. Term.

The term of this agreement shall be from <u>July 1, 1999</u>, through <u>June 30</u>, <u>2000</u>, inclusive unless terminated sooner in accordance with the provisions of this agreement. This agreement may be extended if agreed to in writing by both parties.

Section 3. Compensation.

A. For services provided under the terms of this contract the City shall pay to the Borough the sum of \$26,000 for the period of July 1, 1999 through and including June 30, 2000. The first payment of \$3,250 shall be made 15 days after the signing of this agreement and seven subsequent payments due the first of the month beginning December 1, 1999, and ending June 1, 2000.

Except as herein amended, all other terms, conditions, and specifications remain the same.
