ADDENDUM NO. 3

PROFESSIONAL SERVICES AGREEMENT FOR LOBBYING SERVICES BETWEEN THE CITY OF WASILLA AND ROBERTSON, MONAGLE, AND EASTAUGH

THIS ADDENDUM NO. 3 hereby amends the Agreement to provide Lobbying Services between the City of Wasilla and Robertson, Monagle, and Eastaugh dated February 15, 2000, as follows:
