**SUMMARY STATEMENT:** At the February 12, 2004 Special City Council Meeting the Council directed the Clerk to bring forward an amendment to our legal services contract with Birch, Horton, Bittner and Cherot to extend our contract for an additional one-year term.

Dear Kristie:

This responds to your request that we prepare a renewal of our contract for legal services with the City of Wasilla. We have been pleased to provide legal services to the City for the past four years, and are prepared to renew the contract for another year. However, we also believe that it would be appropriate to adjust the hourly rates under the contract as stated below.

Our current contract hourly rates are substantially below the market rates for legal services in Southcentral Alaska. For example, the hourly rate that I charge for services to new clients ranges from \$200 to \$225, while my hourly rate under our current contract with the City is \$150. That rate has not been adjusted during the four years in which I have provided legal services to the City. For the renewal of this contract, effective as of July 1, 2004, I propose the following hourly rates: Shareholders and Members, \$165; Associates, \$145; Paralegals, \$85.

A form of contract amendment reflecting the terms discussed above, is enclosed for the Council's consideration.

## SECOND AMENDMENT TO CONTRACT FOR PROFESSIONAL LEGAL SERVICES

SECOND AMENDMENT (the "Amendment") to the Contract for Professional Legal Services (the "Contract") between the CITY OF WASILLA (the "City") and BIRCH, HORTON BITTNER and CHEROT (the "Contractor"), executed by the City on June 19, 2000.

WHEREAS, the Contract provides for the Contractor to provide legal services to the City for a term of three years from the date of its execution by the City; and

WHEREAS, the Contract provides for renewal at the option of the City Council of the City for three additional one-year terms; and

WHEREAS, in 2003 the parties agreed to renew the Contract for an additional one-year term; and

WHEREAS, the City Council of the City desires to exercise the option to renew the Contract for an additional one-year term, and the Contractor has agreed to such an extension.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein, the parties agree as follows:

The term of the Contract shall be extended for a period of one year from its current date of expiration. Effective as of July 1, 2004, the hourly rates for legal services under the Contract shall be as follows: Shareholders and Members, \$165; Associates, \$145; Paralegals, \$85. All other terms and provisions of the Contract shall remain unchanged.
