This contract will provide security fencing around the Bumpus Reservoir Facility.

STAFF RECOMMENDED ACTION: Council is requested to award the fencing contract to McKinley Fence Company in the amount of \$47,700.

Any charges reported in these press releases are merely accusations and the defendants are presumed innocent unless and until proven guilty.

On August 30, 2004 at approximately 2208 hours, Wasilla Police contacted Gary A. Reamer, 49 of Chugiak, on a traffic stop near the Parks Highway and Main Street intersection. Reamer was issued a summons for Driving Without a Valid License, cited for No Insurance, and cited for Driving With an Expired Registration.

On August 30, 2004 at 1111 hours, Alaska Industrial Hardware, located at mile 43 of the Parks Hwy. reported discovering a theft which had occurred on August 26, 2004 around 1030 hours. An unidentified male stole a large Bosch breaker hammer attached to a hand truck from the business. The breaker hammer is valued at \$1500. Anyone with information regarding this theft is encouraged to call the police department or Mat-Su Crime Stoppers.

On August 30, 2004 at 0820 hours, a public works water technician discovered vandalism had occurred at the Bumpus water facility on Mystery Ave. Sometime during the evening, the outer skin on the water tank was damaged and the window to the pump house was shattered. No evidence of tampering with the water supply was found. The investigation is continuing. Anyone with information regarding this vandalism is encouraged to call the police department or Mat-Su Crime Stoppers.
