**SUMMARY STATEMENT:** On April 10, 2006 Council awarded the base bid contract to Wolverine Supply, Inc. in the amount of \$2,945,179 for the Phase 1C Apron expansion. Subsequently, FAA authorized additional funding for Additive Alternate No. 1 which will construct a turf runway for short take-offs and landings (STOL) or STOL Runway.

Project History

August 15, 2002 Airport Master Plan Approved by City Council that included Phase 1C Apron Expansion, STOL Runway, and Taxiway Extension.

- November 1, 2004 City Advertised for Engineering Services RFP for Airport Apron Phase 1C Expansion.
- February 1, 2005 RFP scoring completed with Hattenburg, Dilley, and Linnell selected as most qualified to conduct design engineering services and construction administration services for Phase 1C Apron Expansion, STOL Runway, and Taxiway Extension.
- February 14, 2005 Contract Award authorized by City Council to Hattenburg, Dilley, and Linnell for engineering design services in the amount of \$263,158 for Apron Phase 1C, STOL Runway, and Taxiway Extension.
- March 30, 2006 Bid Opening for base bid (Apron Phase 1C), with additive alternates number 1 (STOL Runway) and number 2 (Taxiway Extension).
- April 10, 2006 Contract Award authorized by City Council to Wolverine Supply, Inc. for base bid Apron Phase1C, in the amount of \$2,945,179.
- May 2, 2006 Federal Aviation Administration (FAA) authorizes additional funding for STOL runway.

**STAFF RECOMMENDED ACTION:** In accordance with FAA authorization for STOL runway, authorize contract award to Wolverine Supply, Inc in the amount of \$371,078 for additive alternate number 1, STOL Runway.
