SUMMARY STATEMENT: The City received the attached "Request to Waive Sales" Tax Penalty" form from Jo Ann Fabrics in the amount of \$182.76. Per our attorney, the council may approve the penalty waiver under WMC 5.16.150.B.2 (see Ordinance Serial No. 05-20 attached.)

The following is a statement of facts submitted by Susan Colligan, Director of Finance:

- February 2007 sales tax report and payment was due on March 30, 2007.
- February 2007 sales tax report and payment were received on April 2, 2007.

- The City received a Request to Waive Sales Tax Penalty form from Jo Ann Fabrics requesting a waiver of the penalty amount of \$182.76 on April 5, 2007.
- The City received Jo Ann Fabrics payment for the balance due of \$185.76 (after five working days) on April 9, 2007.
- This is the first time they have requested a penalty waiver.

The council may waive or reduce the penalty under WMC 5.16.150.B.2. (Attached.)

ACTION: This matter falls within the discretion of the council. In accordance with WMC 5.16.150.B.2, the penalty may be waived or reduced by the council.
