SCOPE OF SERVICES

The City of Wasilla is seeking a professional contractor to provide all labor, materials, and equipment to pave approximately 30,000 square feet of parking lot as described in the following specifications. Work will include re-grading and compacting of existing sub-base prior to leveling course to match each driveway entrance/exit and for sheet drainage to low area east as directed by City Engineer. Provide 2-inch leveling course and 2-inch Class B asphalt cement as shown on Attachment A. City Engineer will provide paving limits prior to paving.

This project to be performed in conformance with Municipality of Anchorage 1994 Standard Specifications.

The following items are considered incidental to the bid items:

- 1) Cut and tack coat driveway locations at each tie-in (2 locations)
- 2) Re-grade and compact sub-base prior to leveling course for drainage and driveway locations as directed by City Engineer.


