City-Borough Question; Councilman DeCamp Memorandum Councilman DeCamp read a memorandum dated January 7, 1990 for the record as follows:

Wasilla City Council To:

"After our joint Borough/City meeting last evening at Colony High School, I found myself going over a wide range of emotions in my

The meeting was characterized by the patronizing will and actions of the Boro. assembly which is so typical of any encounter with this group of people now as it has been for so many years. could only describe it as being counter-productive to most of the concerns we voiced. The lists of projects and aid, expressed by the Borough staff, as having been given to the cities over the years was as phony as it could be. The hidden agenda by the Borough was as transparent as it could be --- let's mitigate any real concern expressed with a smokescreen to diffuse the issue and carry control of the meeting. At the risk of sounding some-what paranoid; I have experienced this kind of tactic by the assembly on issues prefer not to deal with for at least 20 years. Preparing the agenda chairing the meeting definitely carries a an edae discussing controversial matters!

At least we were able to say some of what concerned us about our relationship with the Borough and suggest some solutions for change towards a more positive and focused effort to deal with these concerns. The one troubling thing in my mind is the complete lack of understanding by most of the assembly of the concepts we were trying to express. We need to commit to fund a portion of an effort by a consultant, as discussed with the city of Palmer at our last meeting, to research, organize, and articulate our position on municipal unification. The meeting last evening only underscored this need and pointed out the fact that no reliable planning help will be available from the Borough for this effort.

In order to maintain our momentum and progress towards a better community understanding of our proposal I believe we should take the following steps:

- 1) Schedule another meeting with the City of Palmer at the earliest possible time to discuss the joint strategy and continue planning.
- 2) Pledge by resolution, a line of financial support so we begin a search to find someone to research and organize a long-term approach to carry this matter forward.
- 3) Create a liaison with the North and South Lakes Community Councils and others in the intervening area between Palmer and Wasilla to create a better understanding of our proposal in the affected area.
- 4) Voice our concerns about the creation of a task force to study the problem. This sure sounds like the brush-off to me. This is a typical Dorothy Jones solution to everything ----- so she doesn't have to deal with it anymore.
- 5) Any other actions deemed appropriate by the cities to further our goals towards being identified with a positive effort to better local government.

In my opinion, the organization of the meeting of last evening was a deliberate attempt by the Borough to diffuse this effort. The format of having everyone express their concerns one on one with the assembly makes our effort appear unorganized. My suggestion would be to schedule the next meeting in Wasilla at City Hall with the Mayor as chair of his agenda to equalize the situation. How we appear in the media at this point in time is crucial to general support of this concept.

I would invite a discussion of this matter this evening."
