Mr. Nelson briefly explained the reason for this project, that this was the cheapest route to provide gas to the residents in the Knik Road Gas LID.

Jack Krill: Spoke on behalf of the Mat-Su Borough Emergency Services, favors the Vixen Circle Extension to better provide emergency services to the residents of that area.

John Shadrach: Favors the extension and spoke of all the development that has occurred over the past few years to make it a real necessity for more access.

No other comments were made, Mayor Stein closed the hearing to the public.

C. Selina Lane Road Extension

Mr. Gilfilian introduced Peter Curtis of his staff who did much of the technical work on the project and then explained how the project started and where it currently is with 4 alternatives left, labeled 1 through 4.

Mr. Curtis highlighted the facts on each of the alternates, 1 through 4.

Mr. Gilfilian stated that a final design decision needs to be made to continue with the project.

Mayor Stein opened the hearing to the public.

Charles Nevada: Owner of Lots 4, 5 and 6, Snider Subdivision, knew when he bought the lots from Mr. Snider that there was no access and got an easement for use from Mr. Snider. Prefers Alternate #4, would have the least affect on his property, but suggests that the road turn up the 33 foot easement and stay off Lot 1A, Fredricks Subdivision to keep the cost down of purchasing the lot.

Clyde Boyer: Owner of Lot 2, Snider, stated that he and his neighbor Mr. O'Neal granted road easements along with the sewer easement because they were told that the road would be built on the sewer easement, makes more sense to stay on the sewer line easement with a Southern alignment with Lucille Lane. But Alternate #4 would affect his property the least. Feels the City has reneged on their part of the bargain in not building the road before.

Sharon Morris: Owner of Lot 20, Snider, have small children and would like to minimize traffic coming through, also like the road remaining on the sewer line easement.

Mr. Gilfilian stated that the Southern alignment was dropped because of the impact on and the opposition of the owner of Lot 5A, Fredricks Subdivision.

No other comments were made, Mayor Stein closed the hearing to the public.

D. Ordinance Serial No. 90-05; Sales Tax Regulations
Mayor Stein opened the hearing to the public and stated that they
were most concerned with hearing suggestions or changes to the
ordinance.

Arneta Rogers: Stated that the Sales Tax keeps being brought up over and over, is upset with the constant voting on Sales Tax, also didn't like real estate sales being included, suggested a visitors tax and felt it was unusual to exempt export goods.

Joe Johnson: Opposed to sales tax, have gotten along fine without it but if it does go through no business should be exempt. Alternative methods would be to trim the fat and cut the size of government.

John Ward: Opposed to sales tax, not a resident, feels the City should not institutionalize corresion. Coercion

Bradley Ault: Favors sales tax, do need a minimum City government and sales tax can provide a sound basis. Everything increases over the years and does not want to bear the brunt of it with property taxes, also do oppose real estate tax.

Esther West: Does not live in Wasilla, but works here and favors a tax does her shopping here, would just as soon pay the tax in Wasilla as in Palmer.

John Ward: Council should consider a voluntary contribution for residents and non residents, let people pay if they feel like it.
