A. Ordinance Serial No. 90-21; Pertaining to Motorized Vehicle Use on Certain Bodies of Water in Wasilla

1. Ordinance Serial No. 90-21 (Substitute)
Mayor Stein opened the hearing to the public.

<u>Doug Milard</u>: Wasilla Lake, had several questions regarding electric pumps, no wake zones, hours of operation and boat users staying within the central portion of the lake. Mayor Stein and Councilman Carney addressed his concerns.

Bettye Cason: Lake Lucille, stated she liked the substitute ordinance.

Bill Hearitt: Local dealer, Wasilla Lake, stated he would like to see the hours on Friday and Saturday changed to midnight, had concerns with the stock exhaust, would like to see the noise control defined better and would hate to see everything except stock exhaust banned.

Dan Horvath: Wasilla Lake, is pleased with the amended version, has no sympathy for the hopped up boat owners, doesn't feel its fair for residents to loose their enjoyment of their homes and property to the lake users, feels the residents should be considered.

<u>Bill Tull</u>: Echo's Mr. Horvath's sentiments and sees nothing wrong with consideration being given to the residents by not starting up too early in the morning or going on too late at night, supports the ordinance.

<u>Jay Nolfi</u>: Big Lake resident, stated she felt someone on the staff forgot the teeth of this ordinance by leaving out the 2 "C's", courtesy and consideration. Ms. Nolfi stated this ordinance was the beginning of conservation of the lakes in Wasilla and urged the adoption of Ordinance Serial No. 90-21 Substitute.

Troy Sullivan: stated he has lived on Wasilla Lake since 67, has nothing against water skiers, his children learned to water ski on the Lake. Mr. Sullivan stated that he put out several plastic bottles labeled nest or speed limits and the jet skiers used them to see how fast they could go around them in circles to make waves.

Don Loesche: Stated that an ordinance that restricts recreational use scares him, opposed to any such ordinance.

Helen Hearitt: Wasilla Lake, feels that Ordinance Serial No.90-21 Substitute is not too bad, but is also concerned with the toe hold on a controlling ordinance. Ms. Hearitt stated she felt the 2 "C's", courtesy and consideration is a good practice and hopes everyone would use it.

Tony Kilpatrick: Stated that if people work together, can work the problem out without an ordinance, but need a public boat launch on Wasilla Lake.

Sandi Frank: Is concerned with the launching area at Wasilla Lake and read a petition she is putting together for a public boat launch at Wasilla Lake.

<u>Dan Horvath</u>: Urged Council to let maturity and common sense prevail, can't ignore the changes taking place here, have to make a start and urged passage of the document.

No other comments were made. Mayor Stein closed the hearing to the public.
