#### E. <u>Eric Stowe</u>;

Mr. Stowe stated he has lived in Wasilla all his life, but won't continue to live here if he is going to have to pay taxes. Mr. Stowe also stated that police don't stop crime, need good parenting. Mr. Stowe also stated that they do not get their road maintained, Turk Circle.

#### F. Steve Stowe;

Mr. Stowe stated they live in Wasilla Estates and the services are negligible, implementing police is ridiculous, need to keep the City to a minimum and let the people live their lives without intervention.

#### G. Mike Chryson;

Mr. Chryson stated he lives outside the City and he has talked with businesses outside and they want the sales tax to pass so they can get more business. Mr. Chryson stated if the Council wants to see Houston and Big Lake grow into the economic base then pass the sales tax, Wasilla is currently the economic base only because Palmer has a sales tax. Mr. Chryson also stated that the troopers can not legally deny equal protection.

<u>Mayor Stein:</u> Reported that he is working with the City's old auditing firm to get some calculations on what the sales tax may generate, and that youth volunteer clubs are looking for activities to do and he attended the Mat-Su Borough meeting and requested they delay their sales tax issue until November. Mayor Stein also stated that Friday is the last day to file for Council.

Nick Carney: Wasilla Chamber of Commerce President, stated he was disappointed that only 2 members of the Council chose to attend their luncheon and feels that the Council needs to consider the businessman as well because they are here to stay. Suggested that a possible solution in cutting the cost of publishing the agenda is by combining it with the notice of public hearing and cutting the cost that way. Mr. Carney also suggested that the Council is shortchanging the voting public by suggesting that they won't understand information put out. Mr. Carney also stated that information needs to be put out on all the propositions to inform the public.

Faye Palin: Stated she is working with a political action committee called "WOW, Watching Over Wasilla". Stated she takes particular offense to being told that she is not smart enough to understand more than a couple of sentences in a resolution.
