C. <u>Council Memorandum No. 92-100</u>: Road Projects:

Mayor Stein opened the hearing to the public. Mayor Stein explained that the Alaska State Legislature traditionally gives the City of Wasilla a grant of \$200,000 for road paving and road improvements. Administration has proposed a method to allocate that cost towards the roads that need the most maintenance, for example, the roads that are most difficult to maintain. Related to this is a list of local improvement districts which the Council has considered.

Noel Caldwell, Commander of VFW Post #9365, requests paving for Lakeview Drive.

Kenna Lutes, Wasilla City resident, requests paving of Crestwood Avenue.

Lois Covlasky, resident of Lakeview Avenue, requests paving or gravelling of Lakewood Avenue and would like to see all the roads in and near the City paved as soon as possible.

June Robinette, Graybar resident, wants Nelson and Glenwood paved this year. She thanked the Council for what they have done.

Midge Minnick, Lakeview resident, wants Lakeview paved.

Steve Stohl, Wasilla Estates resident, stated that the citizens should take care of their own roads. He would like to see the Wasilla by-pass built, Peck Street cleaned up. He feels the City

needs to draw the line and not spend so much money.

Mike Cryst, Wasilla resident, objects to paving Naomi.

Kari Bowles, Shadowood resident, read and presented a letterfrom James P. Brass, James S. Brass and Dolores P. Brass regarding paving Shadowood. She also presented a sequence of events regarding the paving of Shadowood and the formation of an LID regarding this paving. She requests that the City pay two-thirds of the total cost and the adjacent property owners pay one-third.
