- B. Tom Williams Reindeer Farming; (20 Minute Presentation) Mr. Williams stated that the Reindeer Farm's best market is tourism, but his reindeer have done numerous television shots and commercials. Mr. Williams stated he has sold reindeer all over the United States. He also stated that he began this farm in 1987 after checking and being told that as long as the reindeer were not from the native herd that he could own them. He is now being told to destroy the animals or get rid of them because non-natives could not own reindeer in Alaska. Mr. Williams requested Council support in contacting the Governor's Office, and Senator Murkowski in getting this ruling changed.

Councilman Hjellen requested that Reindeer be added as Item D of New Business. There was no objection from Council.
