5. **PUBLIC HEARING:**

A. Ordinance Serial No. 93-07; Amending Chapter 8.03 (Parks Commission); Mayor Stein opened the hearing to the public.

<u>Mike Chryst</u>: President of S.A.G.E., questioned financing, felt positions should remain unpaid and the neighborhoods take care of the parks, the people using facilities should pay and take care of the facility. Mr. Chryst stated the schools are already being paid for, use these facilities as much as possible, and that no tax monies should be used for special interests.

Wallace Kluntz; Agrees with Mr. Chryst, tax payers should not have to pay for trails that bikes, snow machines and 4-wheelers use. Mr. Kluntz also stated he felt another trail was not needed.

Dale Gardner; Favors the Parks Commission ordinance and commended Council for putting together a

parks commission. Mr. Gardner also stated that there are a lot of people in the community that support parks and recreation.

<u>Sarah Palin</u>; Feels this is appealing to the public, it gives the public more input. Mrs. Palin stated that parks & recreation benefits everyone, not just City residents. She also stated that she would like to see youth become involved in the Parks Commission as ex-officio members.

No other comments were made. Mayor Stein closed the hearing to the public.

 Mayor Stein opened the hearing to the public.

<u>Sally Chryst</u>; Stated her concerns with the law enforcement joint liability protection program, the program would obligate the City for no less then 3 years. Mrs. Chryst requested that Council look at other programs, may cost more to begin with, but is very concerned about the proposed program.

Mike Chryst: Requested Council read through the package and consider how this would apply to their families. Mr. Chryst felt the Council would reject this proposal if they compared it to their own families.

No other comments were made. Mayor Stein closed the hearing to the public.

A. RC & D; ARDOR Economic Development Group; Matching Funds Request Jim Schmidt; Spoke of the projects RC & D is and has helped with around the Borough. Mr. Schmidt stated that RC & D is trying to get the ARDOR designation and they are looking for \$25,000 in matching funds and requested Council consider pledging some funding towards this.

Council had no objection to add ARDOR Funding under New Business Item D.

B. Dale Gardner; Smith Ball Fields

Dale Gardner; Representing Little League Association, Wasilla Soccer Association and Wasilla Amateur Athletic League requesting assistance in finishing the Smith Fields Concession Stand. Mr. Gardner stated Spenard Builders Supply has agreed to sell supplies at cost to finish this project, but need money to pay for the supplies. Mr. Gardner requested that Council consider providing the funding with half the cost as a loan they could pay back and half as a grant.

Councilman Carney requested this item be placed on the agenda for the next regular meeting, 03/08/93.

C. Laura Chase; City Hall Use

Ms. Chase indicated she was here not representing the Chamber of Commerce or anything else, she was here as a City resident and requested Council consider the growth occurring in and around the Wasilla area, consider the gradual crowding taking place at City Hall and look towards the future needs of Wasilla and its City Hall. Ms. Chase stated she felt the City could save tax payers money by purchasing a larger facility now rather than waiting 5 years from now.
