Mrs. Poetzsch displayed pictures of Lot 1, which they would be willing to give to the City for a neighborhood park in return for the vacation of the Hansen Trail easement and urged Council to consider this.

#### B. <u>Steve Stoll</u>;

Mr. Stoll stated he agreed with the Poetzschs, there is adequate access around that property to give up the Hansen Trail easement. Mr. Stoll also commented that he is the only person who ever wrote anything in the Wasilla Nooz. Mr. Stoll also questioned Councilman Carney on how much of a raise he gave his own employees. Mr. Stoll commented on his aggravation he feels with the Shadowood paving project and questioned Mr. Harris on how many times streets have been watered this year. Mr. Stoll then questioned Chief Stambaugh on his retirement from Anchorage and how much he made on that and then commented on the property offered by May Carter as park land.
