1. CALL TO ORDER, PLEDGE OF ALLEGIANCE:

Deputy Mayor Hjellen called the meeting to order at 7:00 p.m.

2. ROLL CALL:

A. <u>Proposed Crestwood Paving Special Assessment District 93P3</u>
Deputy Mayor Hjellen opened the hearing to the public.

<u>Liz Johnson</u>; Stated she did not object to the paving or the formation of the LID, but the majority of her property fronted Cache and requested Council reduce the liability because of the small benefit she will receive. Ms. Johnson submitted written comments (attached).

No other comments were made, Deputy Mayor Hjellen requested that all ballots be turned in for tallying. Mr. Nelson reported that 28 voted in favor, 15 voted in opposition and there were 51 non-response. Deputy Mayor Hjellen closed the hearing to the public.

B. <u>Proposed Mt. Village Plaza Paving Special Assessment District 93P2</u> (To Be Continued) Deputy Mayor Hjellen opened the hearing to the public.

Mika Weinstein, Nye Frontier Ford; Stated that several months ago when this began, it was proposed as a 2/3-1/3 cost share, since then Council has made a policy to go residential 2/3-1/3 and commercial 50/50. Mr. Weinstein stated he feels businesses are being discriminated against because they are in business. Mr. Weinstein passed out a map showing the proposed area and asked Council to reconsider doing the 2/3-1/3 cost share and include the west side of Mt. Village rive in the LID and stated that the property owners of Lot 1, Block 1 and Lot 3B, Block 3 are present and are in agreement with the proposal if Council agrees to the 2/3-1/3 cost share.

Shane Big, Homsteader's Building Supply: Stated that he and his partner are the owners of Lot 1, Block 1 and Lot 3B, Block 3 and are in agreement with what Mr. Weinstein has stated.

Steve Stoll: Has been a City resident for 17 years, and stated that a family spending \$100 a week on groceries spends 10 times as much as a man buying a car, does not feel the City should have to subsidize the paving of these streets. Mr. Stoll also stated he feels the Council should do away with their policy and go back to the code and pave streets that could save lives.

No other comments were made. Deputy Mayor Hjellen stated that the public hearing on Mt. Village Plaza will continue at the end of Unfinished Business.

C. Ordinance Serial No. 93-34; Authorizing a negotiated sub-lease with the Wasilla Lions Club for the Alaska Railroad Depot

Deputy Mayor Hjellen opened the hearing to the public.

Robert Lucus, Wasilla Lions Club Secretary; Stated he was president of the Lions Club and on the City Council when the Alaska Railroad wanted to get rid of the Wasilla Depot, and the City didn't want it. The Lions Club went to the Alaska Railroad and asked them to lease it to the Lions Club, but they wouldn't. The Lions Club then came to the Council and asked them to lease it from the Railroad and the Lions Club would sub-lease it from the City. Mr. Lucus stated that the Lions Club has restored the Depot to a useable condition and non-profit organizations have used it since it was restored. Mr. Lucus also stated that he has written a letter to the City requesting that the Lion's Club get a new lease like the City got with the Railroad.

<u>Rick Gilmore, President of the Better Business Bureau of Alaska;</u> Stated he has an agreement with the Lions for office space in the Depot. Mr. Gilmore stated there is a need for a Mat-Su Chapter of the BBB and they will officially open their office August 5.

No other comments were made. Deputy Mayor Hjellen closed the hearing to the public.

B. John Cole;

Mr. Cole stated he has lived on Knik-Goose Bay Road for the past 15 years and has seen the traffic increase from a few a day to hundreds an hour. Mr. Cole requested that the City get the speed limits

reduced inside City limits to 35 mph to Fern Street and 45 mph to Edland Road then 55 mph.

Council suspended the rules and added Knik-Goose Bay Road Speed Limits as Item D of Unfinished Business.

Hugh Johnson; Stated he is in favor of this suggestion, but does not feel that practically it is enforceable

Chief Stambaugh; Reported on the neighborhood watch coordinator, suggested that warning lights for a reduction of speed on Knik Road may be helpful and that the Police Department has responded to about 500 calls which is about 25% higher then he had originally estimated.

Mr. Cooper; Reported on the repairs to buildings in the Historical Park, a higher rate of visitation to the Museum this summer and bids are out on the Teelands Restoration and is scheduled for opening on August 3.

Mrs. Harris; Reported that the referendum petition repealing Sales Tax Ordinances had been turned in to the Clerk's Office this morning, 260 signatures are needed to place the issue on the ballot and there are over 400 signatures turned in. The Clerk's Office has 10 days to verify signatures, if the petition is insufficient, the sponsor has an additional time frame to collect more signatures, if the petition is sufficient then the issue goes on the October 5, 1993 ballot.

Wasilla City Council:

I have submitted my ballot indicating that I protest the paving in Terrace Manor subdivision. This leter is to clarify specifically what I am opposed too.

I am not opposed to paving in this subdivision, however, I am opposed and object to having to share the costs equally as the majority of my property faces Cache Drive. I, also, object based on my perception that I will not derive any benefits from this project.

My reasons are as follows:

1. I have no need to travel on Crestwood to get to my home. It is more convenient for me to travel on Lucas and enter on Cache.

2. Paving of Crestwood will not solve dust problems created by traffic on Crestwood and Cache. Currently trees on the Crestwood side of my property provide shelter from the dust, therefore, it does not really matter to me if that portion of Crestwood is paved or not.

. Paving Crestwood will increase traffic traveling between Lucas and Lucille creating

more of a dust problem for me on Cache.

4. Regardless if Crestwood is paved I will still have to travel a gravel road to reach my home. This is not the case for any other property owner within the boundaries of this project, that I am aware of.

5. Property owners on Cache are currently not included in the proposed LID. Future consideration of a LID and its formation would result in my paying assessments in

two LIDs.

I request that the Council consider the following:

1. Reduce my liability for the proposed LID assessment or

2. Include the section of Cache in front of my property in the LID or


3. Contact all property owners on Cache to determine if they wish to be included in the current LID formation within Terrace Manor.


