Steve Stoll: Stated that the City will soon be looking for revenue, don't spend this money, save it.

<u>Sally Chryst</u>; Has lived here since 1982, the Museum is not a profit making organization, should not spend this money.

No other comments were made. Mayor Stein closed the hearing to the public.

Mayor Stein opened the hearing to the public.

<u>Steve Stoll</u>; Favors paving Crestwood, but before paving Pinion Court, look at Peck Street, Glenwood Avenue, Church Road where people are dying.

Allen Palmer; Lives on Pinion and has lived here since 1979, has no intention of leaving. The City finally has police, and suggested that if others don't like it then move.

Michael A. Nelson, Sr.; Commented on the reasons for leaving people out of an LID and the ramifications to the other participants of the LID.

No other comments were made. Mayor Stein closed the hearing to the public.

Allen Palmer; Asked Mr. Stoll if he was against progress?

Mika Weinstein; General Manager for Nye Ford, and have never funded Mr. Stein's campaign and as usual Mr. Stoll's comments are not even close to being real.

Ronda Marcie: Stated she was confused about the funding, thought the people paid for improvements, not the City.

Mayor Stein explained how the funding was allocated. No other comments were made. Mayor Stein closed the hearing to the public.

CITY REPORTS:

Mr. Harris; Reported on the paving of the East side of Glenwood Avenue, the Grader is scheduled for new breaks at a cost of \$5,000, brush cutting, fire hydrant inspections, the Lucille Street Bike Path, the Library Roof Repair, the Mt. Village Paving and Crestwood Paving, the Shop Fence bid is out and the Senior Housing Water Well bid is out. Mr. Harris also reported that the Sewer project is behind 4 or 5 days, but should make it up this week and there is a contract dispute with the Contractor and Administration will be working on that.

Mr. Cooper; Reported that the 1917 School House repainting has been completed, the Marion Cabin has a new roof and the Teelands-Mead House is scheduled for work next.

Mr. Baugh; reported that Finance is busy getting ready for the auditors and the sales tax letters to nonpayers has gone down dramatically.

Mr. Nelson; Reported that the main gas line extension has been completed to the airport maintenance building and payroll has just about finished the conversion of all employees to Blue Cross health insurance.

Mayor Stein; Reported on Project Hope, the Governors project is underway at Pt. McKinzey using low risk prisoners to restore the dairy farms. Mayor Stein also asked Council if there was any objection for Administration to pursue a project for the last 6 lots on Holiday Drive for its paving using 2/3-1/3 cost share if the owners came up with their 1/3 up front. That last half of the block was left out of the Shadowood Valley Paving LID and the cost would be approximately \$10,000. Council had no objection.
