Mayor Stein opened the hearing to the public.

Mr. Nelson reported that the proposed Aspen Avenue Gas LID involved 8 lots, 6 responded yes and 2 non responses. Mayor Stein asked for any other ballots to be turned in at this time.

There were no public comments and no ballots were returned. Mayor Stein closed the hearing to the public.

B. <u>Proposed Nelson Avenue Paving Special Assessment District 93P4;</u>
Mayor Stein opened the hearing to the public.

Mr. Nelson reported that the proposed Nelson Avenue Paving LID had yes votes totaling \$58,671.55, no votes totaling \$26,076.24, and non responses. These numbers include the two ballots returned at the

Steve Stoll; Stated he felt \$598,000 is too much to spend on Nelson Avenue, feels it would be better spent on Peck Street or Church Road.

Robert Travis; Favors the project, but is confused with the percentage that residents will have to pay. Mr. Travis questioned how the assessment district will be cost out and stated he feels that speed bumps should be put in because of all the children in the area.

Mayor Stein explained the LID procedure and that the City could only charge for actual costs and if the bids come in at more than 10% above the estimate given to the property owners, the project would have to be taken back to the property owners for a revote. Mayor Stein asked for any other ballots to be turned in at this time.

Mr. Nelson reported that there were 19.25 lots voting in favor of the LID, 9 voting in opposition and 10.25 non responses.

There were no further public comments. 2 Ballots were turned in at the public heraing. Mayor Stein closed the hearing to the public.

Mrs. Cottle commented on the Palmer Library Fee structure advertised in the new paper and suggested that the City of Wasilla should consider this, because Wasilla can not afford to fund the library as it is. Mrs. Cottle also stated she had asked Mr. Nelson about a meeting with the candidates and has not gotten a response and wants to know if the Clerk is going to do anything about a meeting with the candidates. Mr. Nelson stated that a decision has not been made about a candidates meeting.

Ms. Silk asked Council to pass an ordinance in Wasilla to restrict nonpermitted cabs from picking up fares in Wasilla similar to Anchorage.

C. <u>Bill Byers</u>; Peck Street

Mr. Byers requested support from Council to pave the first 200 feet of Peck Street. Mr. Byers stated he would pay for it, he is trying to save the parking lot at the Phillips Plaza and wants this paved either now or guaranteed in the spring.

Councilman Carney requested this item be placed back on the agenda under Unfinished Business. There was no objection from Council.
