<u>Steve Stoll</u>; Feels this is too much money to duplicate the job that the Matanuska-Susitna Borough is doing. Mr. Stoll stated it would be nice to have someone closer, but area wide planning is an area wide function and should be done by the Borough.

<u>Peggy Bear,</u> Wasilla Growth Alliance; Supports this ordinance, they are a group of 7 volunteers doing projects for the City, but need some kind of guidance from someone in the City. Mrs. Bear mentioned several projects that Wasilla Growth Alliance has done such a the Veterans Home Proposal, the Iditarod Park Proposal, the Iditarod Re-start, and they put the Wasilla Brochures together.

Gene Wicker; Wasilla Planning & Utilities Commission; Spoke of the importance of the Planning Commission as Wasilla grows, favors this funding.

<u>Laura Chase</u>; Wasilla Planning & Utilities Commission; Spoke in favor of the funding and suggested that the name of the Planning Department be changed to the Community Development Department to better describe what this department will be doing. Ms. Chase stated that the Planning Commissioners are volunteers and they need a sense of direction, the training is very important in helping them accomplish this.

Jim Tapscott; Wasilla Planning & Utilities Commission; Has been on the Commission for about 7 years, they are miss-named, all they do is approve permits. Mr. Tapscott also stated that the Matanuska-Susitna Borough has done nothing for Wasilla, a planner is needed so this City can move forward in a planned manner.

<u>Sally Chryst</u>; Opposed to the Planning Department, has spoke to the Matanuska-Susitna Borough and they indicated they will work with the Wasilla Planning & Utilities Commission. Mrs. Chryst stated that the funding is not adequate to support a planning department, and the Matanuska-Susitna Borough is doing a fine job.

Jim Palin; Submitted written comments regarding the planning department (attached).

A. Jim Palin;

Mr. Palin asked questions regarding sales tax revenues and if the information was available. Mr. Baugh indicated that sales tax revenues are running about 47% of estimated. Mr. Palin spoke of Ordinance 93-54, sad to see it vetoed, and commented that the Mayor has not brought alternatives to the Council. Mr. Palin also stated that Council Policy 93-05 was not workable and didn't make sense.

B. Sally Chryst; Road Maintenance

Mrs. Chryst spoke about the City's current policy on road maintenance, indicated she had contacted the State of Alaska, the Matanuska-Susitna Borough and the City of Palmer regarding their policies for road maintenance, Wasilla is the only one giving preference to paved streets first. Mrs. Chryst stated that the gravel side streets are becoming one lane streets because the City is not following policy. Mrs. Chryst stated she regrets that tax money is being spent on more paved streets being plowed first. Mrs. Chryst also indicated she felt the proposed 6 day limit for persons to be heard on the agenda is prohibitive.

C. Steve Stoll; Wasilla Nooz

Mr. Stoll indicated that he also felt the 6 day notice is unreasonable, spoke of being escorted out of the Mayor's Office when he volunteered to serve on the selection committee for the Public Works Director position. Mr. Stoll also spoke of the Wasilla Nooz distribution to Council.

Comments on proposed Ordinance No. 93-57, from information provided in Council's 11/22/93 packet:

- 1. Most of the information was provided to the Council for the FY94 budget discussions (in April May 1993) as indicated in Mayor Stein's 11/17/93 CM No. 93-113.
- 2. Based on the information contained in the "Budget Commentary," page B-12, paragraph one, it appears that this same information may have also been submitted to Council for FY93 budget discussion (in April May 1992). Paragraph one refers to:
 - a. Land-use regulations as they relate to the Borough (MSB)
 - b. A city resolution requesting delegation of long-range planning, etc., and capital improvement planning from MSB was passed January 13, 1992 and sent to MSB.
 - c. "This budget anticipates transfer of powers (from MSB) effective July 1, 1992."

This document also lays out several of the responsibilities of the Planning Officer.

This document also states that the City expects that the majority of the planning office costs will be paid by MSB.

This commentary also indicates that staffing would be a planner and half-time clerk.

Comments on the "Budget Commentary"

- A. If administration is to expect the City Council to act responsibly to its request, it would behoove the mayor, as chief administrative officer of the City, to provide the Council (and the public) with current information and reasonable justification for such a request. For example:
 - 1. What has happened with the delegation of planning authority from MSB since January 13, 1992—it is now almost two years since the City requested this delegation from MSB? If things have happened, they are not included in the information provided to the Council and the public on 11/22/93.
 - 2. The list of responsibilities for the proposed planning officer is extensive. However, there is no mention of authority. Is there a job description, which includes authority, responsibility, experience, education, etc. A planning department could be a very important department within the City, but what should it cost, what will it cost, and how will results be measured.

- 3. Is MSB going to pay for a majority of the planning office cost as stated? Personally, I doubt it at this time. However, if a boroughwide sales tax is approved next October, which I believe it will, how will that impact the planning efforts for the City?
- 4. Staffing and salaries—see below.

In regard to the budget, I offer the following comments:

- A. What is the basis for these salaries?
 - 1. What salary and benefit information has been provided to the Council to justify the amounts? \$38,127 for a planner and half-time clerk appears to me to be extremely low for the tasks shown. What should it cost to hire a qualified and experienced planner? Remember, you get what you pay for. To me, this is another example of a need for a salary and benefit survey for the City.
 - 2. In my opinion, the word "permanent" should be removed for all employee reference records; i.e., job descriptions. Permanent implies cradle to grave employment, while the word "regular" does not. You should request a legal opinion.
- B. Why is the City Administration proposing to pay \$8,050 in honorariums to the Planning commission?
 - 1. Does MSB pay honorariums? Do other local governments pay honorariums? If so, how much money, to which commissions, and why? A request for honorariums should be justified with supporting information.
- C. If the Council is to act on the creation of a Planning Department for the remainder of FY94, the Administration should submit a six-month proposal and possibly a tentative FY95 budget. Since the first six months of the planning officer would likely be devoted to becoming familiar with the City and other agencies, it would appear to me that the materials and services budget and some of the capital items would not occur until FY95.

In summary, the information provided to date to the Council does not justify the need, purpose, or the cost for creating a planning department at the City of Wasilla. Depending on additional information that is provided to the Council and public in a professional manner, that addresses, at least, the issues mentioned above, it may be appropriate to create a planning department.
