Mr. Stoll questioned Chief Stambaugh regarding the anonymously written document (Valley Fairytails), felt he did not get satisfaction from Administration and is now coming to the Council and demanded that the Police Chief answer the question honestly. Mr. Stoll stated he felt the idea of the Club Aftershocks using off-duty uniformed police officers was not appropriate.

C. Pat McGraw; Dana Avenue Paving

Don Graber, speaking for Pat McGraw stated he was making a formal request for paving Dana Avenue.

D. Colleen Cottle; Snow machines

Mrs. Cottle spoke about her concern with the races on Lake Lucille, feels the advertisements are inadequate and that the City is not enforcing regulations. Mrs. Cottle stated that the maps of the last race indicated they would be 300 feet from shore, she and her husband measured and the machines were only 160 feet from shore. Mrs. Cottle also stated that she feels someone is needed to direct traffic for these races and that the last race they had a big grader on the lake all day on Friday and does not thing they had a permit from DEC.
