Sally Chryst, Wasilla resident, is opposed to funds and feels the tree planting funds are excessive,

Mike Chryst, stated that in his opinion LID's are a form of socialism. He objects to City funds being used for paving private streets.

Steven Stoll: Wasilla resident, agrees with Mr. Chryst and feels that Lake View is a small traffic count road. He feels this money should be put in the bank to be used for repairing the roads already paved. He feels private owners should pay for their own paving.

<u>Butch Kinworthy</u>, property owner on Lakeview Avenue, stated that he pays property and sales taxes and that everyone should benefit from the taxes paid by putting taxes back into the community. He is in favor of paving Lakeview Avenue.

<u>Sally Chryst</u>, Wasilla resident, stated that sales tax dollars are coming in from everyone. Property owners should pay to improve their own streets. She is not in favor of this paving project.

No further comments were received from the public. Mayor Stein asked for ballots to be turned in. No other ballots were received. Mayor Stein closed the hearing to the public.

## 12. <u>CITY REPORTS:</u>

Mr. Wyatt: Reported on paving projects, the sewer treatment facility, Public Works personnel increase, proposals for janitorial contracts, equipment rental contracts, water system at the Wasilla Senior Center and the City hall building modification starting on Tuesday, June 14, 1994. He stated that the flowers have been planted around the City. He said that an airport lease application has been received from Nolan/Caricuburu asking for consideration of a .03 cent per foot lease cost rather than the required .06 cent per foot cost.

Mr. Deuser: The City has made a major effort to settle the Nuna lawsuit, but this effort was not successful, so we will continue with the present strategy. An application has been filed with the Clerk's office asking for term limits for the Mayor and Council and to exempt sales tax from food and beverages. A legal opinion will be forthcoming to the Clerk's office. The Clerk will distribute copies of this opinion on June 14, 1994.

Mrs. Emmons: Thanked the Council for the Library funding. The summer reading program will begin Saturday, June 16, 1994 and continue for six weeks.

Mr. Cooper: The Farmer's Market will start June 29, 1994 and the Craft's Fair will be held on July 9, 16, 20 and 30 for Mat-Su Borough craftsmen.

Mr. Baugh: The Finance office has spent the last two weeks researching the CIP project funding. The auditor's will be here June 27 and 28 for the preliminary visit. They will be back August 22 to start the annual audit. New business activity in Wasilla is strong.

Mr. Dvorak: Stated he will attend his first meeting with WP&UC tomorrow night. He plans to present a time line regarding the delegation of permitting authority in the near future.

Mrs. Harris: Presented a brief report on the IIMC Conference held in Anchorage in May. She will present a more extensive written report at the Council meeting on June 27, 1994. Election activity will begin in August so the Clerk's office will be busy with elections. The filing period begins August 1, 1994.

Mayor Stein: Had Mr. Carney display the picture presented by Martin Buser at the Iditarod meeting and had Ms. Hjellen display the plaque from the National Guard. The Capital Move Project will now focus on the "Move-It" committee. The Wasilla Newsletter will be out this week.
