Mr. Lucus; Spoke of the history of the depot, and the long range plan the Lion's Club has of raising it up out of the ground 1 foot because dry rot is starting, completing the other half of the basement, putting in a visitors center and gift shop and museum. Mr. Lucus stated they have been attempting to get grants to complete this project but have gotten none so far. Mr. Lucus stated the rummage sale started because of the needs of the people, they get 10 to 40 bags per week of goods, these were being sent

to the villages, but they don't have free transportation any longer. Mr. Lucus also stated that these bags were being stuffed into the depot because he and Judy had to go out of State because his father was ill with heart problems, but everything is now sorted and boxed and not piled everywhere. Mr. Lucus spoke of the City tree contractor leaving topsoil by the depot that now becomes muddy and sloppy when it rains.

I would like to respond to Mr. Deuser's argument against recommending term limits for the mayor and city council members. I am going to quote Mr. Deuser: "Just as the right to vote is considered essential to the democratic principle, so too is the right to run for office. Constitutionally speaking, when fundamental rights are at issue (e.g., the right to vote), the courts apply high standards of judicial scrutiny to determine the validity of proposed legislation"

I have heard this argument before, even council members have stated they want to vote for whom ever they like. Nevertheless a candidate who is a United States Citizen and State Registered Voter cannot run for office unless the residency requirements are established. Title 29 establishes residency requirements not to exceed three years; while City code establishes residency requirements of not less than one year. In other words, if you know a person who is politically active, gets things done, knows how to motivate people, wants to be mayor or a city council member, but has just moved into the City of Wasilla this person does not have the right to run for office. Accordingly, you do not have the right to vote for this person until the residency requirements of one year are met.

Term limits place the same requirements on future mayors and council members. Term limits provide council members a one year break in service to the community and a three year break for the office of mayor. This time out period, gives the individual a chance to step out and see what is going on from the citizen's view point. Many times politicians get tunnel vision and end up on a fast track of tax and spend, tax and spend.

Mr. Deuser 's second argument against term limits if I may quote him, "Although case law exists to support the procedural approach of permitting a petition on term limits to move forward and, if approved, then judicially determine constitutionality, it is my considered opinion that contrary Alaska case law calls for a decision at this point in time before the matter is submitted for petition signatures." I hear Mr. Deuser saying case law exists to support the procedural approach of permitting a petition on term limits to move forward; however, if passed by the voters, could put the city at risk of being sued by a disgruntled politician. If everyone in this city followed Mr. Deuser's advise, no one would risk stepping out their front door or even think of driving a car because of the possibility of getting into an accident and getting sued.

Mr. Deuser's interpretation of term limits being unconstitutional is unfounded. Title 29 of Alaska Statutes is updated on a yearly basis by our elected officials. Our representatives have not seen the need to re-write Section 29.20.140 (d) and section 29.20.230 (c) which

provide for term limits for mayor and city council. Title 29 states: no limit may be placed on the total number of terms or number of consecutive terms a voter may serve on the governing body or as mayor, except by ordinance ratified by the voters. In plain English the voters have the right to place term limits on their governing body.

If the governing body can pick and choose what is constitutional or not constitutional in the statutes, then Title 29 means nothing. How can any citizen respect a government which deals in "smoke and mirror" tactics? The citizens are pacified into thinking they have rights but when those rights are exercised the rules switch to benefit the rulers.

Term limits currently apply to council members, assembly members and mayors in the Municipality of Anchorage, North Star Borough, and the Mat-Su Borough. Obviously these government entities are in conflict with Mr. Deuser. Does this mean these government entities are in violation of the constitution or does this mean Mr. Deuser is wrong. Remember Mr. Deuser gave his opinion, not facts, just his opinion. What about the 4500 people in this community, doesn't their opinion count. If the opinion of Mr Deuser is that the Alaska Statutes are unconstitutional, then the people in this community have no rights, anything goes. Pure Anarchy!

Constitutionally speaking, fundamental rights are at issue here, the right to vote. Just as each of you feel you will be denied the right to vote for whom you like, may I remind you that you already have lost that right through the residency requirement. However, you are denying the right of the people to petition the government and the right to vote on issues allowed by Title 29. By denying this right, you place this republic one step closer to a dictatorship. Is that what you want? If not then why are you afraid of putting the issue on the ballot?

In closing, you have the power to put the issue of term limits on the ballot. Understand that the city attorney does not represent the people of this community but is paid by the city to represent you. He knows what the majority of you desire on this issue and has prepared a recommendation to confirm those desires.

I have prepared an initiative packet for you to review under new business. I would like to remind you, contrary to your tax and spend agenda, citizen's rights are at issue here.

- Sec. 29.20.120. Applicability of apportionment provisions. The provisions of AS 29.20.080 29.20.110 apply to home rule and general law municipalities, except they do not apply to a
 - (1) unified municipality;
- (2) home rule borough if the borough, by home rule charter, provides for reapportionment of the assembly. (§ 7 ch 74 SLA 1985)
- Sec. 29.20.130. City council composition. Each first class city has a council of six members elected by the voters at large. Each second class city has a council of seven members elected by the voters at large. The council of a first or second class city may by ordinance provide for election of members other than on an at-large basis for all members. (§ 7 ch 74 SLA 1985)
- Sec. 29.20.140. Qualifications. (a) A borough voter is eligible to be a member of the assembly and a city voter is eligible to be a member of the council. A member of the governing body who ceases to be a voter in the municipality immediately forfeits office.

(b) A municipality may by ordinance establish a durational residency requirement not to exceed three years for members of the

governing body.

- (c) A municipality may by ordinance establish district residency requirements for members of its governing body. A member of the governing body who represents a district and who becomes a resident of another district in the municipality continues to serve until the next regular election unless provided otherwise by ordinance.
- (d) Except by ordinance ratified by the voters, no limit may be placed on the total number of terms or number of consecutive terms a voter may serve on the governing body.
- (e) This section applies to home rule and general law municipalities. (§ 7 ch 74 SLA 1985)

- Sec. 29.20.150. Term of office. (a) A member of the governing body is elected for a three-year term and until a successor qualifies, unless a different term not exceeding four years is prescribed by home rule charter or ordinance.
- (b) Except when otherwise required by a change in composition or apportionment, if the term of a member of a governing body is changed by charter or ordinance the term of the member holding office when the change becomes effective is not affected.

(c) This section applies to home rule and general law municipalities. (§ 7 ch 74 SLA 1985)

Notes to Decisions – Mandamus lies to compel mayor to perform ministerial act. - Under a former, similar provision neither reason nor the best authority supported the view that because the mayor of a city held an office in which some of his duties were executive or administrative, and thus discretionary, he might not be compelled by writ of mandamus to perform a duty of his office that was ministerial, or substantially so, and as to which any pretended exercise of discretion would have been in legal essence arbitrary and wrongful and thus unlawful. Reherd v. Manders, 66 F. Supp. 520 (D. Alaska 1946).

Sec. 29.20.230. Election and term of mayor. (a) The mayor of a borough or first class city is elected at large. The mayor of a borough or first class city serves a term of three years, unless by ordinance a different term not to exceed four years is provided. The current term of an incumbent mayor may not be altered. The regular term of a mayor of a borough or first class city begins on the first Monday following certification of the election.

(b) The mayor of a second class city is elected by and from the council, and serves until a successor is elected and qualifies. The council of a second class city shall meet on the first Monday after certification of the regular election and elect a mayor who takes office immediately. The mayor of a second class city serves a one-year term, unless a longer term is provided by ordinance. The mayor of a second class city may serve only while a member of the council regardless of the term established for the office of mayor.

(c) Except by ordinance ratified by the voters, no limit may be placed on the total number of terms or number of consecutive terms a mayor may serve. (§ 7 ch 74 SLA 1985)

Sec. 29.20.240. Qualifications for the office of mayor.(a) A voter of the municipality is eligible to hold the office of mayor in a borough or first class city. A member of the city council is eligible to hold the office of mayor in a second class city.

(b) Residency requirements for the office of mayor not exceeding three years may be prescribed by ordinance. (§ 7 ch 74 SLA 1985)
