## A. Holly Hollis; Capital Move

Ms. Hollis spoke of 8 good reasons for moving the capital (attached). Ms. Hollis also spoke of several comments being made about the harm that would be done to Juneau if the Capital moved and brought up things she felt would keep Juneau from being hurt such as, Juneau is the region district for Southeast Alaska, location of the University, mining, fisheries and federal agencies location.

# B. <u>Jim Strong</u>; Iron Dog Classic

Mr. Strong, Business Manager and Director for the Iron Dog Goldrush Classic Snow Machine Race, spoke of the race from Wasilla to Nome and back, the 3 classes of racers and that they are planning for national coverage of the race beginning on February 19, 1995 from Lake Lucille Inn and hoped that Council would consider helping with start up costs.

#### C. Steve Stoll;

Mr. Stoll, resident, spoke of the Lake View Subdivision Street Ends right-of-way and pointed out the Development Code required that all property owners adjacent to or within 600 feet of property under development be notified by mail of a public hearing. Mr. Stoll stated that only residents of the Lake View Subdivision were notified by mail. Mr. Stoll asked Council not to give away the asset of these rights-of-way without proper notice.

#### D. Colleen Cottle:

Mrs. Cottle stated she had come to speak about the Iron Dog Classic, but after speaking with Mr. Strong doesn't think there will be any problem, Mr. Strong seems to be concerned with safety. Mrs. Cottle also stated that they would be gone for the next meeting and asked Council to delay action on the Easy Street

and Island Street rights-of-way regarding the Lake Lucille Street Ends.

## E. <u>Barbara Aldeman</u>;

Mrs. Aldeman spoke about the capital move and what she feels is the number 1 reason to move the capital, economic development with almost a thousand businesses inside the City and several thousand outside, its time to bring the capital to a first class city.

#### F. Rod Cottle;

Mr. Cottle spoke of his concerns on the Lake View Street ends and asked Council to treat all streets equal. Mr. Cottle also spoke about the conflicts in the two surveys done and how easy it to have a discrepancy because of a displaced corner stake or a horse shoe stake being mistaken for a corner stake. Mr. Cottle also stated that at the end of Island Street it is impossible to park in the winter because of the snow pile placed there by the City of Wasilla road crews.

Mr. Dvorak: Spoke of the development code and the worksessions that will be held with the Planning Commission tomorrow evening and again on September 27.
