Mayor Stein opened the hearing on Ordinance Serial No. 95-19 and Ordinance Serial No. 95-20 to the public.

Gene Wicker: Planning Commissioner, stated the Commission wanted to make changes to the Code because of redundancy and the Planning Commission wishes to change their meeting dates. Mr. Wicker indicated that the package before Council is complete and requested that Council support both Ordinance Serial No. 95-19 and Ordinance Serial No. 95-20.

other comments were made. Mayor Stein closed the hearing to the public.

B. <u>FY-96 Budget</u>;

1. Ordinance Serial No. 95-23:

Mayor Stein opened the hearing on Ordinance Serial No. 95-23 to the public.

Barbara Poetzch; Spoke in favor of flowers and the Dinkle Botanical Park. Mrs. Poetzch suggested that possibly next year the City could have a Parks and Rec. Coordinator under the Supervisor who would work with people like herself interested in assisting with fund raising for the Botanical Park.

<u>Steve Stoll</u>: Spoke of the funding of maintenance and debt services, but is concerned with the storm drain system, replacement of the sewer system and development of infrastructure. Mr. Stoll suggested not planting the flowers too close to the road, and suggested that the residents work on the flowers and let the City work on the projects which will bring business to Wasilla and create a vital economy.

<u>John Cannon</u>; Wasilla Planning Commission Chair, requested support of the budget amounts of the Planning Department and the Commission's work plan.

Steve Glos: Spoke of Church Road and asked Council to work on some of the collector streets and supports the flowers.

<u>Kathy Boitz</u>: Agree with development of the Parks, not just planting but also development of the property which will promote tourism. Ms. Boitz suggested that the Parks & Rec. Commission, the Council and the Planning Commission all working together could develop long range plans.

lim Hayes: Requested support of recreational opportunities for the youths. Wasilla Youth Soccer has over 0 children in the outdoor soccer program and they are having problems finding play fields.

George Undt: Executive Board of Kids are People and the Dorothy Saxton Shelter asked for support from the City. Mr. Undt indicated that in the past 2 weeks the shelter has been at capacity, 5 kids per youth day, 214 from the Greater Wasilla area and 113 from within the City limits of Wasilla. Requested support in the amount of \$4,400 for needed equipment outlined in a letter.

Mayor Stein announced that the City Council will hold a work session on the budget on May 15, and could take final action on May 22. No other comments were made. Mayor Stein closed the hearing to the public.

Steve Stoll: Stated he has provided information in the past that the D.A.R.E. Program does not work and stated that there is fairly good evidence that the program teaches gang skills and it teaches drug skills by highlighting them in the children's lives. Mr. Stoll also indicated that the program is taking policemen off the street and taking education out of the class room to provide for the policeman to build public relations. He also stated that this should not be done at the expense of taking a policeman off the street or taking an hour of education away from the kids.

hief Stambaugh stated that this does not take an officer off the street, this grant covers overtime for an icer to teach classes on the officer's day off.

pan Matthews: Stated that any and all education on drugs is necessary, supports the D.A.R.E. program.

<u>Chuck White</u>: Student at Wasilla High School, spoke of a 9 year old girl and the facts she already knows about cocaine, stating that no one of that age should be aware of such facts. Mr. White suggested opening a teen center where kids could get counseling, feel at ease talking to their peers and not be concerned about getting in trouble at school.

Gene Wicker: Supports the D.A.R.E. program.

No other comments were made. Mayor Stein closed the hearing to the public.

1995 Summer Recreation Program

Since my last memorandum to you, the option to provide any type of gymnasium related program is no longer available, except in elementary school gyms. The WPRC does not consider the elementary school gyms adequate for a program.

After further review of the possible swimming related programs, the WPRC has developed the following options:

Option 1: Fully fund two "free", two-hour, evening open swim periods. Estimated total cost is \$7,800. The maximum number of persons allowed in the pool at any time is 105. During the 12-week period of the program, the total number of users is estimated at 1260 to 1600.

Option 2: Up front fund two, two-hour, evening swim periods with a residual fee of \$1.00. The normal borough fee is \$3.00 up to 17 and \$4.25 over 17. Maximum cost would be \$7,800. Actual esimated cost is \$6,500 to \$7,000. Total number of users will probably be slightly smaller than option 1.

Option 3: Fully fund one "free", two-hour, evening open swim on Monday nights at an estimated cost of \$3,900. Provide reduced rate swimming lessons at the Wasilla pool by \$15.00 per person. Preschool lesson fees would be reduced from \$40 to \$25 and other lesson fees would be reduced from \$45 to \$30. Estimated number of participants is 375 for an estimated cost of \$5,625. Total estimated cost for this option is \$9,525.

Option 4: Partially fund one two-hour, evening open swim on Monday nights, using a \$1.00 fee, for an estimated cost of \$3,300. Provide reduced rate swimming lessons at the Wasilla pool by \$15.00 per person. Preschool lesson fees would be reduced from \$40 to \$25 and other lesson fees would be reduced from \$45 to \$30. Estimated number of participants is 375 for an estimated cost of \$5,625. Total estimated cost for this option is \$8,925.

The WPRC recommends the City Council approve OPTION 3.
