Ms. Backus said that VPA's lease states that the Council can reject any sub-lease proposal, therefor, VPA does not wish to enter into negotiations only to have the Council reject the sub-lease. VPA is willing to enter negotiations with EMS for a sub-lease if the City states unconditionally that the City ill allow VPA and EMS to enter into an agreement for a sub-lease.
