Frank M. Smith; Stated he was representing himself and David F. Smith, Michael G. Smith, Frank Todd Smith and Brent Ray Smith, and requested that Council consider adding several parcels to the Core Area as commercial property, Glenwood Avenue/Knik-Goose Bay Road Intersection corner property on the South side of the road, Tax Lot B22, along Knik-Goose Bay Road 2 other parcels, Tax Lot B28 and B5, 1 belonging to David F. and Michael G. Smith currently being used for both residential and commercial, Tax Lot B18 and Lot 1, Catherine Subdivision, in addition is the old hockey rink, Tax Lot B15 approximately 1,000 feet East along Knik Road, each of these properties meet the criteria for the Borough and Wasilla.

Steve Glos: Stated that the community organization he represents prefers the center map which shows more multi-use activities with better wind control, better noise control and still has the possibility for expansion. Mr. Glos referred to Ordinance Serial No. 96-07 and the recommendations contained there and requested that on page 2, recommendation #6 add to the end of the sentence "except in the buffer areas" and on page 3, recommendation #6 add to the end of the sentence ", and work can begin". Mr. Glos also indicated that his group had the Soil and Conservation come out and look at the property, and they are aware that there is wetlands in the Southeast corner of the property and that large scale development without adequate swells could start silting up the wetland area and mess up the aquifer.

Ron Rucker; Parks Commission Chairman and Ad hoc committee member, addressed some concerns with the scaled down map, the American Legion is not unhappy with only having one more field, the Little League is not as happy with their situation, however, they may be able to alleviate some of their concerns by utilizing the Smith Fields. The soccer fields can also serve as football and rugby fields, and thinks that soccer will develop 2 fields at a time. Mr. Rucker also took the reduced plan to the Parks and Recreation Commission and they had no problem with the scaled down version.

Mr. Walker; read letter from Kim-Marie Walker, copy attached.

raine McCombs; Stated that the equestrian group prefers the center map. Ms. McCombs stated on a resonal level it hurts to see this development, is not against team sports, but enjoys the woods.

hn Harris: Stated he has seen the arguments over this for the past couple of months and indicated that the ap on the right seems to be a pretty good compromise, vote on it and get going, work out the problems that come up in the future then.

Steve Glos; Stated the Community did not get the involvement in the beginning, wants to make sure the trails are on the map that does get adopted.

Wendy Yardley; Log Cabin All Sports Association, Driving with Buggy Society, Morgan Horse Association, likes the center map, the map on the right side does not include an arena. Is concerned about the soil, don't let it all blow away.

Thank you for the opportunity to sit on the recent Ad Hoc Committee to review issues regarding the proposed development at the Bumpus Recreation Area site.

Because I cannot attend tonight's Meeting, please accept the following as comments to be added to the minutes. (I also have copies for each of you):

Topic I: Environment Assessment dated 2/22/96
With regards to the final Memorandum received by the Wasilla City Council and Mayor from Mr. Dvorak, Mr. Lent, and Mr. Naegelecon the subject:
Summary of concerns and development ideas from the ad hoc Committee to Review Bumpus Recreation Area Design

A very important consideration is not in this final memorandum! You will note that on Appendix 'A' of the final memorandum, 'Concerns' are addressed in numerical order. Some of these concerns raise issues on whether the environment can sustain and/or support the magnitude and types of uses proposed for the Bumpus site.

Once the City Council approves a conceptual design, *I urge* the City Council to send the conceptual design to appropriate agencies for their review. Because the expertise required for environmental assessment is not fully contained within the City, please consider using the resources of the Wasilla Soil and Water Conservation District, ADEC, US Army Corps of Engineers, ADNR, and ADF&G. Many of these agencies have technical expertise and financial resources to accommodate long range planning and development to minimize any potential irreversible damage to the site and to surrounding private real estate.

# Topic 2: Draft Map presented at ad hoc meeting Wed, Feb. 21, 1996

This map is more aligned with a multi-use area theme. It showed 3 large soccer fields that could alternatively contain 2 smaller playing fields for a total of 6 smaller fields.

Please consider limiting the number of soccer fields to 4 large regulation fields with a total of 8 alternative smaller fields contained within.
