VOTE: The agenda as amended passed unanimously.

COMMISSION/AGENCY REPORT

Mr. Stan Tucker, Mat-Su Borough Assembly Member:

- Reported the assembly approved two gas local improvement districts and rejected one.
- Reported the tall structure ordinance has been postponed.
- Spoke on the latest developments with the port project.
- Announced the borough is considering an advisory ballot question on zoning and a proposition on a two- percent borough wide sales tax.
- Stated ten boards will be up on continuance at the next assembly meeting.

Mrs. Bernadette Rupright, Wasilla Parks and Recreation Commission:

- Reiterated the commissions' wish to place the Nelson Avenue bike path outside of Iditapark boundaries.
- Stated she does not support constructing the Nelson Avenue bike path with funds which are earmarked for Iditapark as monies are available in another fund specifically designated for bike path construction.

MOTION:

Council Member Cottle moved that the Mayor and her administration proceed with negotiations with Kinetic Aviation and develop an appropriate package of invectives from the City of Wasilla, for presentation at the next council meeting. Items to be considered are: development lease leveraging; tax waivers or deferrals; site and facility development options; and coordination of Federal, State, and Borough incentives.

MOTION:

Council Member Chappel moved to fund up to \$4,000, with 50 percent of the funding to come from council contingency, 25 percent from administration, and 25 percent from the planning budget, for a Flightseeing Tour sponsored by the Chamber of Commerce. (See page 5.)

The motion to postpone failed with Council Members Cottle and Keller in favor. (Council Member Patrick was absent and excused)
