The public hearing was continued from the Regular City Council Meeting of June 12, 2000.

Mr. Harold Newcomb, Mr. Bob Lucas, Mr. Ray McCarthy, Ms. Pat Hjellen, Ms. Bernadette Rupright, and Mr. Garvin Bucaria spoke in opposition to the question of Home Rule being placed before the voters at the October 3, 2000 regular city election until more information can be gathered and the public better educated on the issue.

MOTION: Council Member Keller moved to adopt Ordinance Serial No. 00-41 by substitution.

VOTE: The motion passed with Council Members Cottle and Fuller opposed.
