C. Ordinance Serial No. 02-30: Authorizing The City Of Wasilla To Enter Into A Lease Agreement With Matanuska-Kenai Inc., dba MTA Wireless In Exchange For Cellular Telephone Service.

Mayor Palin opened the public hearing.

Mr. Dave Glenn, Grasshopper Aviation, raised concerns regarding the impact of the cellular tower to future development at the airport.

Mr. Rod Ewing, MTA Wireless, encouraged the council to adopt Ordinance Serial No. 02-30.

There being no others who wished to be heard, the public hearing was closed and discussion moved to the council.

VOTE: The motion failed unanimously.
