The mayor reported that she received requests to purchase city owned property on Riley Avenue adjacent to the Wasilla Assembly of God Church. She discussed land disposal options available in accordance with the code and requested direction from the council on how to proceed with land disposal.

After discussion the general consensus of the council was to direct administration to enter into negations with the party who made the first formal offer to the city and to dispose of the land in a manner that provides the greatest financial benefit to the city.
