Mayor Keller:

- reported on library funding in FY-05;and
- briefly highlighted the activities of various city departments.

Council member Cox:

- asked about the salary range for dispatcher positions;
- mentioned that the Bumpus soccer field needs repair; and

Deputy Mayor O'Neil:

Council Member Lowe:
