- noted she is confident the City of Wasilla can accomplish the goal of constructing a new library provided the process is well planned; and
- talked about the need to identify operating costs associated with the construction of a new library.

Council Member Metiva:

- spoke in support of moving forward with the process of constructing a new library and community center; and
- spoke about the need to develop the downtown area.

Council Member Woodruff:

- spoke in support of moving forward with the process of constructing a new library;
- talked about the challenge of losing potential library construction sites due to rapid development;
- commented on sales tax collection (whole numbers versus percentages);
 and
- talked about the need to work cooperatively with the Mat-Su Borough for the betterment of the entire community.

Council Member Massie:

- thanked everyone for attending the meeting; and
- noted she supports the construction of a new library.

Deputy Mayor Larson:

- commented on proposed regulations drafted by the Alcoholic Beverage Control Board in regard to liquor license transfers from the Borough into the City; and
- spoke in support of formulating a well thought out plan prior to placing the question of a sales tax increase on the ballot for the construction of a new library.
