Title: Liquor License Renewals and Transfers

It is Council Policy to protest an application for a liquor license transfer or renewal if any of the following conditions exists:

- Delinquent Assessments;
- 2. Delinquent Water or Sewer Utility Payments;
- 3. Violation of WC 9.04 Business License Ordinance;
- 4. Violation of WC 11.12 Trash Enclosure Ordinance;
- 5. Violation of WC 14.04 Abandoned Vehicles and other Property;
- 6. Encroachments;
- 7. Violation of MSB 17.43 Wasilla Development Code; or
- 8. Delinquent Taxes.
