Dear Property Owner:

The Wasilla City Council has received inquiries as to the possibility of paving Glenwood Avenue from Knik Road west to at least Century Circle. Accordingly the Council has requested that a preliminary canvas of interest be made of owners of property that would be benefitted by the project to determine if there is a willingness to share in the cost.

The owners of the eight (8) adjacent properties would be expected to contribute a total of one third of the project costs. Payments plus interest, could be made over a period of five years through formation of a Local Improvement District (L.I.D.).

We ask that you respond on the enclosed form as an expression of your interest in proceeding with the proposed project. If the majority of the property owners are in favor of the project the City may authorize engineering work and develop a more precise cost estimate, and conduct a formal, binding vote. This expression of interest does not bind you or the City to proceed with the project. An unsigned, or returned form will be considered as "not interested".
