#### **BACKGROUND**

The Wasilla Planning Commission adopted a resolution at the July 18, 1995 regular meeting establishing a Capital Improvements Program priority list for submission to the Mat-Su Borough. Projects nominated by the Commission are ranked for inclusion in the Borough's six (6) year CIP planning process. Planning Commission Resolution No. 95-14, was adopted as the result of three (3) public worksessions to nominate and rank projects relevant to the Greater Wasilla area.

The Borough would like to get the final list from the City by August 7, 1995. In addition, the Borough process encourages contributing boards and councils to hold a public hearing before adopting the official CIP list. Due to advertising requirements, the earliest that a public hearing can be held is August 14, 1995. Staff is copying this information to the Council now so that the Council will have the greatest amount of time to review the list prior to the public hearing. It is expected that action to approve an official list will be taken after the public hearing in order to try and meet the requirements of the Borough CIP process.

# WASILLA PLANNING COMMISSION RESOLUTION NO. 95-14

A RESOLUTION OF THE WASILLA PLANNING COMMISSION OF THE CITY OF WASILLA, ALASKA, RECOMMENDING PRIORITIES TO THE WASILLA CITY COUNCIL FOR INCLUSION IN THE MATANUSKA-SUSITNA BOROUGH'S SIX (6) YEAR CAPTIAL IMPROVEMENT PROGRAM (CIP), FY1997 - 2002.

WHEREAS, the Wasilla Planning Commission held a public worksession on June 20, 1995, and on July 5, 1995, to discuss and rank new and existing capital improvement project priorities for the City of Wasilla; and

WHEREAS, the City of Wasilla represents a community of more than 4500 people who are also citizens of the Mat-Su Borough; and

WHEREAS, the Mat-Su Borough provides for many important roads, services and public facilities serving the greater Wasilla community, either directly or through service areas and contracts for construction and maintenance; and

WHEREAS, the City of Wasilla is also served by the State of Alaska which maintains highways, roads and other public facilities including the Parks Highway, Knik-Goose Bay Road, Palmer-Wasilla Highway, Main Street/Wasilla-Fishhook Road, Crusey Street, Church Road, Old Matanuska Road, Lucus Road and the Wasilla Airport; and

WHEREAS, the State of Alaska administers the federal airport improvement program for the Wasilla Airport; and

WHEREAS, the Wasilla Planning Commission wishes to recommend community priorities for needed Borough and State capital improvement projects in the greater Wasilla area, particularly highways, roads and public facilities;

NOW, THEREFORE, BE IT RESOLVED, that the Wasilla Planning Commission, of the City of Wasilla, hereby recommends that the Wasilla City Council establish the projects identified in Attachment "A", as City priorities for inclusion in the Matanuska-Susitna Borough's six (6) year Capital Improvement Program (CIP), FY1997- 2002, and adopted here by reference.
