Source of Data:

The information contained in this reports was compiled from the Wasilla Police Department records system.

Wasilla Police Department Goals

Promote and maintain crime prevention activities with emphasis on citizen involvement, public awareness and community policing.

Manage our resources in an effective and efficient manner so as to achieve a high level of productivity.

Wasilla Police Department Mission Statement

The Wasilla Police Department's mission is to provide the best possible law enforcement and crime prevention services, staffed by experienced, educated officers utilizing the most modern equipment and facilities.

The Department will maintain a cooperative working relationship with other local, state, and federal law enforcement agencies as well as all other emergency services organizations. Mutual assistance agreements with law enforcement and emergency services organizations (to include Palmer Police Department, Alaska State Troopers, Alaska Division of Fire Prevention, Mat-Su Borough Public Safety, and area private security services) will be established.

The department will initially be staffed with 9 commissioned officers and a Chief. Qualifications for commissioned personnel will be as required by Alaska Police Standards Council with an emphasis on academic achievement and exceptional communication skills.


The primary emphasis of the Department is to prevent criminal activity coupled with enforcement of local, state, and federal laws. The Department will support crime prevention and programs such as Neighborhood Watch, Crime Stoppers, merchant education, and related programs. Crime Prevention Fair

During January the Wasilla Police Department hosted a crime prevention fair that was held at the Cottonwood Mall where 18 separate agencies attended and provided information on topics ranging from traffic safety to fire safety. Demonstrations were also provided by the State of Alaska crime lab on fingerprinting and evidence collection.

Junior Crime stoppers

Purpose:

To involve school age children in the reporting of crimes within the schools.

Through a cooperative effort with the local crime stoppers board Mr. Messick has continued to assist their efforts in forming junior crime stoppers programs in the valley schools.

Community Relations

Purpose:

To increase the awareness of the community in crime prevention approaches and programs to include.

Public Service Announcements

Conducted through the area media of a variety of topics to include information about seminars to be held.

Home and Garden Show

A community booth was available to ask questions about the Police department and programs available.

Public Inquiries

Usually handled at the Sub station located in the Cottonwood creek mall and relating to the working of the police department and programs available to the public.

Youth Court

After a presentation by Mr. Mark Begich at the Wasilla Chamber of Commerce Mr. Messick was assigned the task of coordinating and forming a youth court in the valley. To date several organizational meetings have been accomplished with the Mat-Su school district, Palmer and Wasilla Police departments, State Division of Youth and Family Services, youth probation, City of Palmer, City of Wasilla and Mat-Su Borough. Mr. Messick has also been successful in obtaining a state grant for the initial funding of the program.

WASILLA POLICE DEPARTMENT HISTORY

Wasilla Police Department

History and Background Information

After numerous attempts by concerned citizen groups and elected officials during the 1970's and 80's a vote was held in October 1992 to establish a 2% sales tax to fund the formation of a police department for Wasilla. The vote was held in October 1992 and passed by 61 votes. The sales tax went into effect in January of 1993 with an anticipated start up date for the police department of July 1. 1993.

In January of 1993 Mayor John C. Stein hired Irl T. Stambaugh a Captain with the Anchorage Police Department as the first Chief of the Wasilla Police Department, the appointment was confirmed by the Wasilla City council on January 11, 1993.

On February 16, 1993 Chief Stambaugh begin work with the City of Wasilla, during the initial start up phase the police department was under construction in the old school house attached to city hall. The first order of business was to hire a Secretary. Angella Long became the first secretary of the department, (she was later promoted and is now the first female officer with the department).

From March to July 1993 Chief Stambaugh and Secretary Long continued work on the start up of the Police department which included buying the necessary equipment which was everything from computers, cars and guns, to the screening of more than 150 applications for officers.

On April 22, 1993 offers of employment were made to the following personnel, all of whom accepted.

The experience level of the Officers selected ranges from 2 years to 10 years of work in law enforcement.

On June 16, 1993 the above listed Officers started work for the City of Wasilla. From June 16 to July 1st the Officers received in service training and equipment issue.

July 1, 1993 the Wasilla Police Department became operational after an opening ceremony held at the Wasilla City Hall. Justice Ed Burke from the Alaska Supreme Court conducted a swearing in ceremony for the Officers, the opening was attended by representatives from the Palmer Police, Anchorage Police, Seward Police, Alaska State Troopers, FBI and numerous citizens and political figures from the community and surrounding area.

Approximately 5 minutes after the department became operational the first call was received, that call was a burglary to the Wasilla Feed store at 501 N. Airport Drive. That case remains unsolved as of this report.

In August 1993 Mr. Jim Messick was hired as the community relations coordinator for the Wasilla Police Department, his duties include neighborhood watch, Crime Stoppers, Community and Business seminars on a variety of topics and a bicycle registration program.

In September 1993 Officer Rick Manrique attended a DARE (Drug Abuse Resistance Education) instructor program and is in the process of adding the DARE program to the area schools for the 1994 school curriculum.

In October 1993 an initiative repeal of the sales tax was rejected by a 2 to 1 margin. Officer Robinson was promoted to Sergeant.

In November of 1993 Secretary Long was promoted to Officer, she has recently completed the Municipal Police Academy at Sitka, Officer Achee was promoted to Investigator. Ms. Debbie Callison was hired as the Administrative Assistant.

On July 1, 1994 the Wasilla Police Department celebrated it's first anniversary.

In July 1995 two additional positions were funded by the city council, one position is a full time school liaison position that will work with the staff and children in the area schools. Off. Vercelline was assigned to the position which became full time in January of 1996. The other position was to assign Off. Manrique to the Mat-Su drug unit, this position is funded through grant monies received from the State of Alaska. Reserve Officers Tim Jessen and Bob Dixon were hired as full time officers to fill Officers Vecelline's and Manrique's vacant positions. Officer's Jessen and Dixon are in the process of completing training at this time.
