CITY OF WASILLA ORDINANCE SERIAL NO. 97-73

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING CHAPTER 9.04, BUSINESS LICENSE GENERAL.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

<u>SECTION I.</u> Classification. This ordinance is of a general and permanent nature and shall become a part of the Wasilla Municipal Code.

<u>SECTION II.</u> <u>Purpose</u>. To amend Chapter 9.04 by eliminating a renewal fee for business licenses.

SECTION III. Amendment. Section 9.04.040, Fees.

9.04.040 Fees. [EFFECTIVE JANUARY 1, 1984,]T[t]he license fee for each business shall be [TWENTY-FIVE DOLLARS (]\$25[.00)] for the calendar year or any part thereof. Effective January 1, 1999, the renewal fee will be eliminated for any licensed business showing no sales tax payment delinquencies for the previous 12 months. [EFFECTIVE JANUARY 1, 1994] I. R. C. Section 501(c)(3) and (4), nonprofit organizations, shall [WILL BE REQUIRED TO] obtain a c[C]ity [OF WASILLA] b[B]usiness I[L]icense at no cost.

<u>SECTION IV.</u> <u>Effective Date.</u> This ordinance becomes effective upon adoption by the Wasilla City Council.
