

A RESOLUTION OF THE CITY OF WASILLA, ALASKA AUTHORIZING ALLOCATION OF MATCHING FUNDS FOR THE IDITAPARK, AIRPORT SNOW MACHINE TRAILHEAD, AND BUMPUS PAVED PEDESTRIAN PATHS/TRAILS GRANT APPLICATION.

WHEREAS, the City of Wasilla is dedicated to the further development of Iditapark, the Airport Snow Machine Trailhead, and Bumpus Recreation area;

WHEREAS, the Parks and Recreation Commission supports the application of matching grant funds for paved pedestrian paths/trails at Iditapark, the Airport Snow Machine Trailhead, and Bumpus Recreation area.

NOW THEREFORE BE IT RESOLVED, that the Wasilla City Council supports grant applications being submitted by the Parks and Recreation Commission to the State of Alaska for the paved pedestrian paths/trails at the Iditapark, Airport Snow Machine Trailhead, and Bumpus Recreation area; and

BE IT FURTHER RESOLVED, that if the City of Wasilla receives grants from the State of Alaska for Iditapark, the Airport Snow Machine Trailhead, and Bumpus Recreation area, for paved pedestrian paths/trails, that the grants will be accepted and the city agrees to allocate funds to match the grant funds up to the amount of \$15,000 per project, for a total not to exceed \$45,000.
