SUMMARY: Ordinance No. 98-08 appropriates funds to the projects to be funded, in part, from the 5.5 Million Bond Issue and covers the construction seasons of 1998 and 1999. There are also other funding sources involved in several of these projects. Dust control funds are a possibility over the next two years but are not included at this time.

The expenditures for the projects are based on preliminary estimates at this time and are subject to change. As the projects develop and solid engineering estimates are available, we will be coming back to the council with amending ordinances to transfer funds out of the reserve and between projects.


