We support and recommend the following amendment to Senate Bill 231:

p 18

Line 22 City of Wasilla

Approve funding for investigating and taking corrective cleanup action of ground water contamination of the Old Knik Landfill/Smith Ball Fields.

50.0 Oil/Haz

This request will provide funding for the City of Wasilla to perform a site investigation of ground water under the Old Knik Landfill and to perform corrective cleanup action if contamination is discovered.

This property is currently used by the Wasilla Little League. This property is known as the Smith Ball Fields. The ball fields have no wells for irrigation or consumption. This is due to the Department of Environmental Conservation's and the City of Wasilla's concern that if water wells are installed, the water may be contaminated and that there is too great of a potential for children to come into contact with chemicals and/or consume the water. The City has lacked financial resources to conduct a ground water investigation to determine if the ground water is contaminated.

The funds will be used to drill monitor wells and to conduct a sampling program for a minimum of one year, to investigate corrective cleanup action options, and to perform such actions. These funds will reduce a potentially high exposure by taking measures to ensure the health and safety of children and the community.
