

Memorandum of Agreement between The Matanuska-Susitna Borough and The City of Wasilla for the Public Safety Complex



The Matanuska-Susitna Borough and the City of Wasilla have determined that there is a need for additional public safety facilities to house Fire, Emergency Medical, Rescue and possibly Police services. The parties agree that it may be in the best interest of the public to consolidate any needed construction to reduce costs, improve efficiencies to the public, and to provide better service to the public. The Borough and the City have developed a basic concept for a shared Public Safety Complex. Both parties shall notify each other no later than April 7, 1999 if they choose to build a joint use public safety building.

The Borough and City administrations have jointly agreed to a location for the Public Safety Complex within Block 2 of Wasilla Airpark Industrial Subdivision. The City has purchased lots 2-6 for the complex. The Wasilla Lakes Fire Service Area has agreed to move ahead with funding of the preliminary design and construction documents. Final design) space and cost allocation shall be subject to the approval of the Borough Assembly and Wasilla City Council no later than July 21, 1999.

Upon concept and site selection approval by the Borough Assembly and City Council, no later than May 5, 1999, the project design work can begin with an estimated 60-day completion after approval of an architect. Construction of the facility could then commence with 60-90 days after final action for design and financing authorizations. Completion and possession of the facility would hopefully occur 12 months after construction begins.

Wasilla Public Safety Complex Meeting of March 19,1999

Present: Kevin Koechlein, Jack Krill, Jim Swing, Dave Carroll (MSB) Tim Krug, Walt Gilmore (City of Wasilla)

Meeting was to go over progress on the building and how it is going to proceed.

Land Issues:

Tim reported that the city has completed the purchase of the lots and is going to replatt them into a single lot. They have hired an engineer to do the survey and other work to get this accomplished. MSB can assist with the platting process to expedite this along. This replat is not seen as a potential hindrance to the schedule.

The site will need to have soils study completed before any RFP can be issued for construction. This will be a part of the work MSB to do for the design specifications.

The issue of permits was addressed with the following permits or other applications identified:

Wasilla- land use permit, driveway permit, sewer and water connection

MSB- historical preservation review

State-fire Marshall review, DEC,

Utilities- MEA, MTA, ENSTAR, City of Wasilla Public works The general consensus was permits would be a part of the contractors responsibility unless otherwise provided in the RFP.

The other land issue is that there will need to be a site agreement between the borough and city for use of the site. This needs to address costs, space etc. for each party as well as the term of the agreement. MSB to take the lead on drafting the site agreement.

The city also stated they had asked DOT for a traffic light at Parks and Lucille with the city paying a portion of the costs.

Design:

Discussion on the merits of design build vs. conventional design and bidding. MSB PW has little experience with the process but supports its concept and will assist. The process was clarified as to what the initial design specification will look like. It will be a set of standards and requirements for space, contents etc.. It will then be up to the proposers to

define the building and provide the actual design. The borough and city would then select the best proposal in terms of space, design and cost.

W. Gilmore expressed concerns over what extent the city would be involved in the overall process. The intent has been and remains that the city would be involved in the entire process including selection of the A/E for design specifications, the final design spec package, and then for the final RFP selection. The city needs to identify who their key people will be in the process.

The proposed time schedule was discussed with the following key times:

April 6- assembly approves funding for A/E
RFP for A/E out and received by May 1
Mid May assembly approval of A/E
June 1 A/E firm starts
July 10 final design spec delivered and sent to assembly and council
End of July- RFP issued
Sept 5, RFP due in
End of Sept. RFP awarded
Oct construction begins.

Other key items that will occur concurrent with the above are the platting action, funding mechanism, permits and other applications as needed.

Wasilla Public Safety Complex Construction Time Line

The proposed time line presented here is based on many of the key elements being performed simultaneously. If each item is strung out and not worked in conjunction with others the time frame may double, eliminating the ability to begin construction in 1999.

April 1999

- Assembly approval of funding for design and specifications
- MSB to request proposals from qualified design firms
- MSB and City develop site agreement for land
- Final platting issues identified and any platting actions initiated
- MSB Finance Dept. begins development of the COP process
- MSB and City finalize building needs

May 1999

- MSB and City sign site agreement for land use
- RFP awarded for design/specifications
- Consultant begins work for a design build bid package
- City and Borough complete platting requirements
- Apply for preliminary permits, work orders for MEA, MTA, ENSTAR

June 1999

- Final design package delivered to MSB and City, submitted to assembly and city council for approval
- Cost estimates complete and provided to MSB Finance Dept for funding by COP or other method.

- Based on design submit final permit applications as needed, request for service to utilities.
- Complete any final land issues

August 1999

- Finalize funding approval
- Receive RFP's or construction and evaluate
- submit RFP to assembly and city for approval

Fire & EMS Space Requirements Combined Pubic Safety Building

Apparatus Room: 12,000 square ft.

6 pieces of Fire Apparatus

2 Engines @ 42'

1 Ladder Truck @ 58'

1 Pumper Tanker @ 42'

1 Rescue Truck @ 38'

1 Brush/Wildland @ 28'

4 Ambulances

@ 28' plus 8' = 36'

The configuration of the apparatus room with the housing of fire apparatus and ambulances will require 5 bay with 14' wide doors and 14' in height, the 14' height is to accommodate the height of the fire apparatus. The size of each bay should be 20' to provide enough room to work around the apparatus and ambulances with compartment doors open and the restocking of various equipment, tools and appliances and fire hose. The projected spacing of the apparatus, based on actual apparatus and ambulance sizing would require ample room to the front and rear of each piece of equipment for various tasks that are needed to be performed after emergency or routine responses to insure the equipment is response ready as soon as possible. Example: bay 1 -1 engine (42'), 1 pumper tanker (42') total of 84", bay 2 - 1 rescue truck (38'), 1 engine (42') total of 80', bay 3-1 ladder truck (58') 1 brush/wildland unit (28') total 80', bay 4 2 ambulances (28') total 56', bay 5 2 ambulances (28') total 56'. The 14' to 20' around the fire apparatus will allow for safe and easy access around the equipment. The length of the ambulances 28' x 2 @ 56 also requires an additional 8' behind each ambulance for removal of litters and other equipment in a safe manner, this would require up to 75' to 80' of space for the ambulance bays. Additionally during the period of time after responses when the equipment is being cleaned and reloaded the additional space will provide adequate room for the personnel to perform the tasks. Presently in all the public safety buildings, when cleaning and servicing equipment to prepare it to be placed back in service or reloaded on the apparatus, the vehicles are parked outside on the aprons. This situation creates extreme difficulties, particularly during late night hours or extreme weather conditions. Additional fixtures and equipment that will be placed in the apparatus bay will be a fire hose washer, a fire hose dryer, and wire type

lockers for hanging and storing personal protective equipment, approximately 35 to 40 for paid n call fire responders and 35 to 40 for paid on call EMS responders. The dimensions of the apparatus bay with 5 bays @ 20' wide by 100' deep would be 100' x 100'. Another section of the apparatus room would require 4 rooms at the rear, each room would be approximately 20' x 25' and would consist of the following: Room 1 - air room which would contain an air compressor and cascade unit for refilling SCBA bottles, 2 wet sinks, a work bench and drying area for decontamination, cleaning, servicing and minor repairs of SCBA units. Room 2 - EMS, fire decontamination room, this room will provide for the decontamination and cleaning of EMS and fire equipment that becomes exposed to various contaminants such as body fluids, bloddborne pathogens, haz-mat, etc. and would contain showers and other decontamination equipment. Room 3 - EMS supply and equipment storage area, this room would provide secure storage for EMS medical supplies and equipment carried on and necessary for EMS service. Room 4 secure storage for fire equipment, such as fire hose, tools and appliances, and other related equipment. The area above the 4 rooms can be identified as an area that all heating and mechanical components of the structure can be located.

The total area required for these 4 rooms - $20' \times 100' = 2000$ square ft.

Total area required for apparatus room 100' x 100' = 10,000 square ft.

Training and conference rooms: 5000 square ft.

The concept and intent of the training/meeting rooms and conference rooms is a shared space concept designed to meet the present and future needs of the Borough EMS, fire and rescue and City of Wasilla and the police department as a primary users and other agencies as secondary users. To provide for adequate room to conduct multiple training or meetings and small breakout or conference rooms, the conceptual design would consist of 2 training/meeting rooms approximately 40' x 40' providing 1600 square ft per room. These 2 rooms would be separated by 2 conference/breakout rooms approximately 20' x 20' with rollaway partitions. Each training/meeting room will provide space, depending on seating type, fixed or temporary (moveable) and worktable arrangement that would accommodate up to 90 people. When the rollaway partitions for the conference rooms are open or stowed, it would create 1 large room, approximately 4000 square ft. which depending on the seating type and work table arrangement, could possibly accommodate approximately 230 people. An area would be provide within the training/meeting room for a small kitchenette with a sink, microwave oven, coffee maker, and other amenities. An additional area will provide restroom

facilities to service the users of the rooms, these areas are projected at approximately 1000 square ft.

Domicile space, paid on call staff area: 4000 square ft.

The intent of this area of the facility is to provide functional space for paid on call personnel to operate from. At present neither the Central Mat-Su Fire Department or the Wasilla Ambulance Service has full time fire fighters or medics. This does not preclude the concept of using paid on call personnel from staffing the facility on a shift type schedule. With the increase in EMS responses and fire responses, utilizing the paid on call personnel will provide definite advantages to the delivery of emergency services to the core area. In the conceptual design of this area of the facility, if the time occurs when the need to hire full time emergency response personnel for 24 hr. staffing arises, this facility will have the necessary amenities to meet the need. There are several areas that will be needed. A dormitory/ sleeping area, this will require approximately 75 square ft per person, for a total of 1050 square ft. for 14 personnel. The design would incorporate an area that will be acoustically separated from the adjoining areas. The dormitory will consist of pods that have 1 bed, 1 desk and 3 wardrobes.

A kitchen area for the personnel to prepare meals. It should provide for food preparation, warming and storage (refrigerated and non-refrigerated). It should include a refrigerator/freezer, range, microwave oven, dishwasher, sink and garbage disposal along with counters, upper cabinet storage and pantry storage. This kitchen area can also be utilized for larger functions and activities that may occur in the training/meeting rooms. The projected size of this area is approximately 300 square ft.

A day room/ dining room for the on shift personnel to take breaks and eat. This projected size of this area is approximately 600 square ft.

Privacy toilet/ shower room - this would provide unisex privacy rooms for the paid on call personnel. The projected size of this area is approximately 800 square ft.

A non-disrobing locker room with adjoining unisex toilet/shower room for additional paid on call staff that are not being used for shifts, but respond for emergency calls. The projected size of this area is approximately 600 square ft.

2 office areas, one for ambulance service paid on call officers and one for paid on call fire officers. These offices would be equipped with desks, computer, fax

machine, file cabinets and would provide work areas for the completion of incident reports and other essential paper work as required by the services. The projected size of these offices would be 20' x 20', totaling 800 square ft.

A general office supply/ office equipment storage room. The projected size of this area would be approximately 450 square ft.



STAFF RECOMMENDATION:

Staff respectfully recommends the acceptance of the site selection committee's recommendation to house a joint use public safety facility building in the Wasilla area.

SUMMARY STATEMENT:

In August 1997 a site selection committee was formed to identify a site for a joint use public safety facility for fire and EMS operations and the Wasilla Police Department. The committee was made up of representatives from the City of Wasilla Planning Department, Planning Commission, Department of Public Safety, and the Matanuska-Susitna Borough's Central Mat-Su Fire Chief. The committee conducted several meetings from August 1997 through January 1998. The meetings included the public, City of Wasilla Parks and Recreation Commission, and the Wasilla Planning Commission.

The need for a new and improved fire station has been identified continuously in the Wasilla Lake Fire Service Area Capital Improvement Program (CIP) since 1990. In 1995 discussions were held exploring the idea of a joint use public safety facility within the City of Wasilla. The meetings included design criteria, identification of space through a needs assessment, and selection of a possible location in the City of Wasilla. A consultant was hired by the City of Wasilla, with the concurrence of the Borough, to develop a conceptual design, which was presented to both the City Council of Wasilla and the Matanuska-Susitna Borough Assembly.

The site selection committee was formed after the concept design was presented to the city and borough. The City of Wasilla Planning Commission recommended individuals to the City Council to serve on the site selection committee. The Borough Manager approved Central Mat-Su Fire Chief Jack Krill's participation on the site selection committee. Through a series of public meetings four potential sites were identified as follows:

1) 5 acres plus adjoining property on or at the old Wasilla airport located on Lucille Street, Herning Avenue, and Nelson Avenue.

- 2) A general area located near Main Street, Crusey Street, Bogard Road, and Nelson Avenue.
- 3) A tract of land at approximately mile 0.5 Knik Goose Bay Road and Glenwood Avenue.
- 4) A tract of land in the area of Church Road and the new Wasilla Airport.

The site selection committee developed a comprehensive grading and evaluation process to analyze the advantages and disadvantages of the four sites. The evaluation process identified two parcels as priorities - the old Wasilla airport and surrounding land and the area around the Parks Highway and Church Road. Initially both the Wasilla Parks and Recreation Commission and Wasilla Planning Commission opposed the old airport area as a potential site for the joint use Public Safety Building. The Wasilla-Lakes Fire Service Area and Wasilla Ambulance Service opposed the Church Road site.

Since the original opposition by the Wasilla Planning Commission and Parks and Recreation Commission new development has occurred in the area of the old airport. The Wasilla Wonderland Playground and the skate board park have been constructed. Both the Wasilla Planning Commission and Parks and Recreation Commission have reconsidered their recommendations regarding the site of the joint use Public Safety Building. By having a Public Safety Building located near the park a higher level of safety and security can be provided, thus reducing vandalism and other crimes.

In April 1998 the Wasilla City Council amended the 1996 Wasilla Comprehensive Plan to indicate the Lucille Street and Nelson Avenue, old Wasilla Airport location is the site best suited for a proposed Public Safety Building. In December 1998 the Wasilla City Council authorized the purchase of five lots, approximately 4.6 acres adjacent to the old Wasilla airport for the purpose of locating a public safety facility.

Since the action of the Wasilla City Council on this issue the Mat-Su Resource and Development Council (RC&D) has passed a resolution supporting the location of a public safety facility in the area of the old Wasilla Airport. Additionally, the Wasilla Area Seniors Inc. and the Wasilla Chamber of Commerce have passed similar resolutions in support of this location for the public safety facility. The area of the old Wasilla airport is centrally located to the core area of the City of Wasilla and strategically located near the larger commercial areas of the city. Additionally, the site is centrally located to the population base of the Wasilla-Lakes Fire Service Area and Wasilla Ambulance Service. The location is readily accessible by the on-call personnel and will provide improved access to the main road system. The site also has all necessary utilities presently available for development of a public safety facility: municipal water and sewer, electricity, natural gas, and the availability of fiber optic telephone service.

The construction of a new and larger public safety facility will benefit the borough in several ways. Besides being well located within the service district, the borough will no longer have to pay approximately \$26,000 in annual rent to house the EMS operations and ambulances. These services will be provided by the new facility. Also, the current fire station in Wasilla will be used exclusively for the maintenance of the entire Matanuska-Susitna Borough Public Safety equipment.

Currently, the Borough and City administrations are working together to develop memorandums of understanding outlining the ownership and maintenance of the new joint use public safety facility.

The Matanuska-Susitna Borough Department of Public Safety has recommended approval of this site and the plan to construct a joint use public safety facility within the City of Wasilla.

The Planning Commission reviewed and supports the recommendation of the Department of Public Safety to construct a joint use Public Safety Building within the City of Wasilla for the purpose of housing Wasilla-Lakes fire and EMS operations and the Wasilla Police Department, to be located at Wasilla Airpark Industrial, Block 2, Lots 2-6.





Wasilla City Council Action Memorandum CM No. 98-21 requests the Public Safety Building Site Selection Advisory Committee (PSBSSAC) to proceed with Identifing specific parcels near Lucille Street and Nelson Avenue for a future public safety facility.

The intersection of Lucille Street and Nelson Avenue has properties without facilities on all the corners, except for the southeast corner which has a ministorage constructed. The northeast corner would require clearing and negotiating with several property owners. The northwest corner would require clearing, negotiating with several property owners and it would be difficult dealing with the elevation changes on the site. The southwest corner is owned by the City of Wasilla, Brian Eberhard and the owners of Valley Feed and Seed (if you desired to also obtain Block 2, Lot 1 of Wasilla Airpark Industrial Subdivision). The southwest corner is cleared, level, has all utilities, and the owner of the majority of the properties (4.7 acres) has agreed to sell the property for what appears to be a reasonable cost.

Therefore, the PSBSSAC recommends to the Wasilla Planning Commission to recommend to the Wasilla City Council to proceed with purchasing all of Block 2 of Wasilla Airpark Industrial Subdivision. The attached resolution has been drafted for your approval.

SUMMARY: Wasilla City Council (WCC) Memorandum No. 97-44, WCC Resolution No. WR97-38, and Wasilla Planning Commission (WPC) Resolution No. 97-25 recommendations required additional analysis be done prior to the dedication of any property for a Public Safety Building.

The WPC established a Public Safety Building Site Selection Advisory Committee (PSBSSAC) according to memorandum PCM No. 97-19. This committee selected four areas of Wasilla (as attached) to be considered. The committee recommended specific items to be rated along with a suggested score to the WPC.

The Planning Commissioners rated each of the four areas and then their scores where normalized and tallied to discover area 1 and area 4 tied. As a tiebreaker the normalization process was changed to add up the total points and not the normalized points and area 4 received slightly more points than area 1. The Wasilla Planning Commission then passed Resolution No. 97-41 (as attached) which recommends that area 4 — Church Road and Parks Highway is selected.

Once an area is selected by the Wasilla City Council, the Planning Commission will look forward to recommend to the City Council the specific recommended parcel in the approved area.

PROBLEMS:

- 1. Staff of the Matanuska-Susitna Borough Fire Department does not appear to be interested in locating to area-4.
- 2. The Matanuska-Susitna Borough has not yet agreed to a joint-use public safety facility.

ADVANTAGES / DISADVANTAGES FOR EACH OPTION:

Staff has prepared a list of pros and cons for each of the suggested motions. These pros and cons are not complete. Council members are welcomed to add input.

SUMMARY STATEMENT:

Beginning in approximately 1992, the borough and city of Wasilla began discussions on the concept of a joint public safety complex in Wasilla. The facility would potentially house EMS, rescue, and fire services along with the Wasilla Police Department. A

needs assessment and building needs were completed by GDM Associates that outlined the basics of a joint facility and spatial needs based on current levels of service and predicted growth for five, ten, and fifteen years.

INTIMITEDIT

Since the beginning discussions, numerous potential locations were evaluated by the city and borough with the final selection being at the end of the Wasilla park strip. This location was deemed to have the best access, availability of utilities, and was strategically located. The city has since purchased additional land in the area to consolidate the ownership of all parcels by the city.

The borough and city have signed a memorandum of agreement to facilitate the design and construction process and to assure that the building is built as economically and quickly as possible. To continue the working relationship and process, funding is required to hire an architectural firm to complete the design specification for bidding. The borough and city have recommended that the design build process be used to reduce costs and allow for the private sector builders and designers to have the flexibility to submit proposals for the facility.
