

**SUBJECT: Proposed 1999 Strip Paving Projects**

**SUMMARY:**

In 1997, the voters approved a \$5.5 million bond for road improvements. Ordinance 98-08 set forth budgets for certain road projects. Those projects were completed in 1998 or are to be completed this year.

The City has been extremely successful in keeping the projects under the budget amounts. There are remaining funds that can be used for other City road projects. Therefore, the Administration is proposing to use a portion of the approximate \$1.5 million remaining funds for strip paving. (Public Works expects the total cost to be approximately \$400,000.)

The selection criteria for strip paving projects includes: lack of drainage problems, high City maintenance costs, is a commercial or connecting road, or is a previously "unfinished," and where no underground utility work is anticipated. City crews will prepare the road base by grading and shaping ditches. No cuts or fills are anticipated. No driveway approaches will be constructed, nor will any drainage improvements will be made.

Public Works expects to advertise a bid for 1999 strip paving towards the latter part of July. The work would be done in late August and September. (Alternatively, with the MSB's concurrence, the City may be able to negotiate a change order directly with the selected low bid MSB strip paving contractor.)

(Note: The attached spreadsheet shows the proposed strip paving projects. The spreadsheet includes Wonderland Park paving projects. The Wonderland Park projects funding would not be from the road bond funds, but would be from Council appropriations for the Park.)
