SUMMARY:

The Chief Wasilla Statue and Memorial Project is moving forward with the support of the Mat-Su Borough Mayor and Assembly, and with the Alaska State Legislature's commemoration.

Project coordinator Harold Newcomb and I met on April 27, 2000. Other meeting attendees included Mayor Salmon, Mayor Guinotte, Bekki Spencer from our museum, a local principal and other interested citizens. We were honored to have relatives of Chief Wasilla participate in the meeting and help educate us by providing information on Wasilla's history.

The statue and memorial will be a reality in Wasilla. I encourage us all to participate in the private-sector fundraising efforts that will help build this fitting tribute to our indigenous peoples' heritage. It is Mr. Newcomb's committee's intent to exhaust all means of private-sector fundraising before approaching any level of government for money.

There may be a potential resource partnership between the city and the project committee in the future, namely, we should be able to assist the project with a statue location and historical records-keeping assistance. The Mat-Su RC & D is requested by the Project Committee to act as trustee/administrator of the funds collected for the project.

COMMEMORATING A LIFE HISTORY

CHIEF VISILLA

Chief Visilla was born in the 1840s; however, his actual birthday and birthplace is unknown. His formative years were spent during the Late Russian Period, a time when the natives enjoyed an equitable trading relationship with the Russians. The influence of the Russian church had expanded as far as the Village of Susitna. Visilla's name is apparently derived from the Russian surname, "Visiliev," meaning "Basil." Visilla's six-foot stature leads credence to a Russian origin.

He was in the prime of his life during the Early American Period. It is probably during this period that he rose to power, becoming Chief of Benteh (meaning "among the lakes"). His ability to acquire riches through trade and ingenuity helped gain him the status as Qesh'qa. As head of the local lineage group Chief Visilla was responsible for the wellbeing of the village. Chief Visilla was also noted for his strength in forging a lasting peace among neighboring Dena'ina clans and the Copper River Ahtna. Visilla was also a great shaman who practiced the Russian Orthodox faith.

After the premature death of Chief Visilla the Seward Weekly Gateway reported: "... he became chief through his mental and moral superiority and ruled the other natives sternly. Because of his character and intelligence he was held in much esteem"

The Twenty-first Alaska State Legislature recognizes the life history of Chief Visilla. His generosity, willingness to assist others coupled with his ability to forge peace with his neighbors contributed greatly to the development of the Mat-Su Valley.
