SUMMARY:

The Wasilla Municipal Code requires that the Wasilla Planning Commission (WPC) review the Comprehensive Plan at least one time every two years and make recommendations to the Wasilla City Council (WCC).

The WPC reviewed the proposed Water Systems Facilities Master Plan and adopted this Masterplan, April 10, 2001 at a duly advertised public meeting. RFP has been issued for a master plan the sewer and airport masterplans and the commission anticipates the completion of both of these plans very soon.

The commission believes that the appropriate time to physically amend the Comprehensive Plan is when all the masterplans are complete and have met with client final approval.

UPDATE TO THE CITY OF WASILLA COMPREHENSIVE PLAN.**

WHEREAS, pursuant to Wasilla Municipal Code (WMC) 2.60.010, the Commission is to undertake a general review of the Comprehensive Plan at least once every two years and recommend to the Council amendments to the plan that it determines to be appropriate; and,

WHEREAS, the most appropriate time to update the comprehensive plan would be when the master plans for sewer, water, airport, etc., are complete; and,

WHEREAS, currently there is no funding available for an update; and


WHEREAS, the City of Wasilla will need to print the updated Comprehensive Plan; and,

WHEREAS, the Water Systems Facilities Master Plan, date January 2001 has had final client review from the Wasilla Planning Commission.
