A road rename request was received by the Planning Office from Mark Warfield a resident of W Railroad Drive. Mr. Warfield has had difficulty receiving his mail because of the similarity of Railroad Drive and Railroad Avenue. The Planning Office sent letters to all of the property owners adjacent to Railroad Drive and asked if there was a name that they felt would be better suited for their street. It was agreed that W Foggy Drive would be acceptable by all parties concerned.

The Planning Office has received a letter from the MSB stating that W Foggy Drive is not a duplicate and fits the area.

WHEREAS, the property owners on West Railroad Drive have expressed their concerns; and,

WHEREAS, conflict exists because there is a Railroad Avenue and Railroad Drive within city limits.


