SUMMARY STATEMENT:

Modifications of Street names are required within the City of Wasilla to conform to WMC12.08.010, Street name changes.

The street name changes are as follows:

- Rename S. Mack Road to S. Mack Drive
- Rename W. James T. Avenue to W. James T. Circle
- Rename W. Mill Site Road to W. Mill Site Circle

Residential address numbers will not change, only the street designations. The effective date for these changes will be November 1, 2002.

These changes will be advertised in the Frontiersman. Public Works Department will notify affected property owners as well as the U.S. Postal Service.

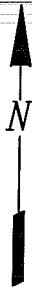
