RESOLUTION NO. WR94-06

A RESOLUTION OF THE CITY COUNCIL OF WASILLA, ALASKA ESTABLISHING CITY PRIORITIES FOR MATANUSKA-SUSITNA BOROUGH CAPITAL PROJECTS.

WHEREAS, the Matanuska-Susitna Borough exercises areawide powers within the City of Wasilla; and

WHEREAS, the 4400 residents of Wasilla are citizens of the Borough; and

WHEREAS, the Mat-Su Borough both directly and through service areas plans, designs, contracts for construction and maintains important public roads and public facilities serving the Wasilla area; and

WHEREAS, the Wasilla Planning Commission, City Council and Administration wish to relate local community priorities for needed capital improvement projects involving Borough roads and public facilities; and

WHEREAS, newspaper advertisements and newsletters have invited citizen participation and that a joint public hearing on capital improvement priorities was duly advertised and held by the Council and Planning Commission on December 14, 1993.

NOW THEREFORE BE IT RESOLVED by the Wasilla City Council that the following Mat-Su Borough capital projects are hereby established as City priorities for the Fiscal Year 1995:

Matanuska-Susitna Borough Roads

- (1) Peck Street paving and extension to Fishhook Road
- (2) Seward Meridian Road upgrade, Parks Highway to Bogard Road
- (3) Seward Meridian Road extension from Bogard Road north to Seldon Road
- (4) Seldon Road extension east to Bogard Road (Bogard Road extension)
- (5) Seldon Road connector from Wasilla-Fishhook west to Lucille Street
- (6) Endeavor Street upgrade access to Lake Lucille Park
- (7) Vine Road connection Parks Highway to Knik-Goose Bay Road

Matanuska-Susitna Borough Public Facilities

- (1) Herning-Teeland-Meade Building historic restoration
- (2) Central Library Wasilla
- (3) Community Center Wasilla
